The March meeting of the Housing and Community Development commission will focus on the allocation of funding from a variety of sources. These decisions were discussed and approved in separate Advisory and Review Committees (ARCs). In the coming County Board approval process, the recommendations will be approved by funding source. The information below is organized by funding source and, in some cases, funding sources have recommendations from multiple ARCs.

Funding Sources

On Tuesday, March 2, Lake County received the actual funding amounts for the PY2021 entitlement grants, including Community Development Block Grant (CDBG), HOME and Emergency Solutions Grant (ESG). This information arrived after the Affordable Housing and Public Services ARC meetings occurred. Staff made minor adjustments to reconcile to the grant amounts. Those changes are noted.

Overall, this funding round is larger than a typical annual funding round. This is primarily due to the final allocation of CDBG funding from the CARES Act (CDBG-CV3). The final funding amounts for all grants involved in this funding round are as follows:

Please note the grant amounts listed above include administrative funds that are used by the County. Admin amounts are listed in the funding charts below.

Community Development Block Grant- Coronavirus (CDBG-CV3) Funding Recommendations

CDBG-CV3 is the second allocation of additional CDBG funding to the County appropriated through the CARES Act. Funded projects must fall within the guidance to "prevent, prepare for and respond to the Coronavirus pandemic." The funding is subject to CDBG regulations but there is no cap on the amount that can be spend on public services. Projects were scored and reviewed at the Public Services, Public Improvements and Affordable Housing ARCs. There have been no changes to the ARC recommendations listed below since they were approved. The table includes amounts added by North Chicago for their funding which results in one additional project and slightly higher funding amounts for some projects, as noted in the table.

Community Development Block Grant (CDBG) Funding Recommendations

CDBG is largest of the entitlement funds received by the County. In addition to the County's funding, the funding recommendations below include North Chicago's funding that is managed by Lake County. The first chart includes funding for public improvement, affordable housing and administration. The total amount available for these projects is \$2,487,656.

In order to accommodate the difference between the funding estimates used with the ARC and the actual funding amounts, staff reduced funding to CPAH's Riverside CILA expansion. This leaves CPAH

with enough funding to start on one CILA. The second CILA can be funded with funding that may become available mid-year.

While the Public Services cap was waived for prior program years due to the pandemic, it is back in effect for PY21 funding. No more than 20% of funding can be used for public services applications. The total amount of funding available is \$432,739. Please note that funding was granted to proven housing programs based on a multi-year funding approved last year. In the chart below, this includes Catholic Charities, North Suburban Legal Aid Clinic and Prairie State Legal Service's (PSLS) Homeless Prevention Programs as well as PSLS's Fair Housing Program. Scores listed for these programs and their funding amounts were sized on an annual budget.

Emergency Solutions Grant (ESG) Funding Recommendations

Emergency Solutions Grant is focused on homeless programs. By regulation, not more than 40% of funding can be awarded to shelter and outreach programs. These recommendations include a grant to Lake County to cover expenses related to the administration of the Homeless Management Information System that is required for this funding. The following chart reflects slight increases to grant amounts to match the HUD award.

Video Gaming Revenue (VGR) Funding Recommendations

The Video Gaming Revenue is invested consistent with the policy which prioritizes services related to gambling addiction. In December 2020, the Lake County Board revised its Video Gaming Revenue Policy to provide ongoing support for 211 through United Way of Lake County in a noncompetitive, multi-year commitment. This year, there is an additional opportunity to invest in 211 through the CDBG-CV funding. Between these two funding sources, United Way is recommended for \$200,000 of funding for 211.
