Dear Mr. Prindle,

According to page 14 of the Contract Specifications, Lake County Grading Company is eligible for an Incentive Payment based on completion of work within the closure limit of 28 calendar days. The Incentive Payment is based on a rate of \$5,000.00 per calendar day for each day of completion prior to the expiration of the 28 calendar days allowed for the road closure. The maximum payment under this incentive plan was limited to 10 calendar days.

I am pleased to notify you that with the completion of specified work and the opening of the road on August 27<sup>th</sup>, using only 18 calendar days out of the 28 calendar days allowed, you have earned the full incentive. The amount that you have earned is \$50,000.00; 10 calendar days (maximum) at \$5,000.00 per calendar day.

Five calendar days will be added with change order two and paid on pay estimate five dated 11/30/2020. The additional five calendar days of incentive will be added at a later date and paid once that change order is approved by the county board.
