RE: Design Engineering Services for Fairfield Road at Monaville Road Intersection Improvements

Dear Mr. Emde:

Benesch has prepared the below summary and attached Change Order request for additional services related to the design of improvements to the intersection of Fairfield Road at Monaville Road in Lake County. The below services are required for completion of the project and were not included in the original scope of services for the design contract.

Force Main Easement Vacation Document Preparation – 48 hours

This work includes preparation of an Abrogation of Easement word document which includes the legal description of the easement as well as an exhibit showing the easement to be vacated. Easement will be prepared, and comments addressed as required. This work does not include legal services or recording of documents. Scope also covers increased complexity and multiple coordination meetings required for the design of the force main relocation due to the Village restrictions for maintaining operations which was not anticipated in the original scope.

ESR Submittal & IDOT Coordination – 24 hours

This work includes preparation of an updated ESR exhibit, submittal to IDOT, updating of the Wetland Impact Evaluation, and follow-up coordination with Bureau of Local Roads and Streets. It also includes preparation of exhibits and minutes, presentation of the project to IDOT Detour Committee, and incorporation of the Detour Committee comments.

Land Acquisition – Septic and Driveway Regrading – 36 hours

This work includes addressing comments on grading and materials for the property at the southeast corner of the intersection and updating plans to align with final negotiations. Regrading of the property and coordination with Mellen Septic Services was required to meet septic needs. Additionally, the property owner requested adjustments to both the residential and commercial driveways. These revisions resulted in the creation of multiple exhibits showing modified cross sections, plan view grading sheets, as well as the incorporating the changes into the underlying terrain to generate the contours.

MTJ Scope Reduction

The original scope for MTJ included review of prefinal pavement marking and signage, which was not required due to use of LCDOT standards. A reduction of the unspent MTJ contract value is included in this Change Order.

Contract Document Changes for March 2021 Letting – 80 hours

This work includes additional administration, preparation of and updating of plan and specification documents due to the delay in letting to March 2021. Pavement marking plans were prepared in accordance to LCDOT standards for the original letting date. Due to the delay in letting significant changes to the plans and quantities were required. Updating to this new standard, implemented in fall 2020, required detailed call-out changes for sizes and materials, specification revisions, updates to legends, splitting, re-calculating and re-checking quantities and also updating the various



pavement marking schedules. Additional quality checks on all documents were completed to meet 2021 letting standards. These changes represent an increase of \$22,493.69 to the design contract.
