The County has access to \$3,063,567 in additional Community Development Block Grant (CDBG) through the CARES act. This funding, referred to as CDBG-CV3, is granted to "prevent, prepare for and respond to the Coronavirus pandemic." The funding is subject to most CDBG regulations but there is no cap on the amount that can be spend on public services.

Community Development released a public application round late November to solicit applications from community partners. Those applications were reviewed and scored by staff. The resulting funding recommendations were approved by various Advisory Recommendations Committees (ARCs) and the full Housing and Community Development Commission. The following funding recommendations include some funding that the County manages on behalf of the City of North Chicago where the City made recommendations, as noted in the table. The total proposed funding recommendations are presented in the following table.
