Pursuant to your request, we are pleased to submit this proposal to investigate the replacement of the existing Coarse Mechanical Bar Screen at the Des Plaines River Water Reclamation Facility

Background

Screening at the Des Plaines Water Reclamation Facility is currently provided by a WSG Solutions/ Envirex coarse mechanical bar screen and two (2) fine bar screens by Headworks with JWC wash press grinders.

The coarse mechanical bar screen has rusted and is experiencing structural failure. The other equipment is believed to be in operational condition.

LCPWD now desires to conduct an assessment to determine appropriate remedial action.

Scope of Services

Our proposed scope of services for this assignment includes the following:

- 1. **Documentation Review** RHMG will review documentation, including shop drawings, O&M manuals, and construction plans prior to the site investigation to establish the project history and background.
- 2. Site Visit For Equipment Evaluation RHMG will conduct a site investigation to determine the condition of the existing coarse mechanical bar screening equipment in the raw wastewater pump station.
- 3. Memorandum Detailing Replacement Recommendations RHMG will make recommendations on required equipment replacement, conceptual cost estimate, and anticipated implementation schedule.
