Matt Meyers, Assistant County Administrator, said in September 2020, the County passed a resolution committing Lake County to net zero greenhouse gas emissions. Kelly Shelton, Shelton Solutions, gave the overview on the County's status through this plan.

Update and discussion on the public outreach components of the Clean Air Policies development.

Hannah Mulroy, Planning Building and Development (PBD), and Eric Waggoner, PBD Director, gave a presentation on efforts to engage with the public on the County's clear air policies.

Ms. Mulroy previewed an interactive website that will be used to provide the public information on the County's efforts and provide the ability to solicit feedback.

Discussion ensued, including an inquiry as to a public hearing process. Mr. Waggoner explained the path for any ordinance other than a zoning ordinance would only go through the formal committee process, not the Zoning Board of Appeals. In addition to the formal committee process where public comment is invited, staff will look at a virtual town hall to gather input in an informal setting outside the committee meeting. The town hall will be publicized through Board Member newsletters, website, press release, and social media.
