A written public comment was received on March 19, 2021 from Maya Ziv El, Samuel DiGrino and Susan Perlman of Prairie State Legal Services:

Thank you for the opportunity to comment on Lake County's housing and community development needs in this unprecedented time of the COVID-19 pandemic. Prairie State Legal Services, Inc. has provided free civil legal services for low-income people, the elderly, people with physical, mental health and developmental disabilities, domestic violence survivors, those dealing with substance abuse issues and other vulnerable members of our Lake County community since 1977. Housing issues have always been a primary focus of our organization. We have a team of experienced attorneys able to respond to legal needs of Lake County residents threatened with urgent housing problems.

Fairness and equal justice under the law are fundamental American values. Civil legal services help fulfill American's promise of justice for all. In a civil case, a person who cannot afford a lawyer is not granted one by the state, even though the stakes in a civil case can be very high. Prairie State ensures that people whose basic needs are at risk have access to justice even when they lack the means to hire a lawyer. We believe that civil legal services will be an essential component of Lake County's recovery from the humanitarian, public health and economic crises caused by the COVID 19 pandemic.

Our Fair Housing Program for Lake County enforces federal, state and local laws that protect against illegal housing discrimination based on race, color, national origin, religion, sex, disability, those who have children, among other protected classes. We regularly represent clients in negotiations with landlords, assist clients with disabilities

obtain accommodations and modifications, investigate potential discrimination through our fair housing testing program, and represent clients in enforcement cases before HUD and the Illinois Department of Human Rights and Human Rights Commission. Besides legal representation, we provide educational events and seminars to community groups, social service agencies, and housing providers themselves, on their fair housing rights and responsibilities.

Our Legal Advocacy Homelessness Prevention Project serves low-income Lake County residents who are eligible for affordable or subsidized housing or are renting in the private market. It also includes low-income people who are in foreclosure proceedings or tenants that rent from a property owner who is in foreclose. Through this project, we offer a wide range of legal representation to those facing imminent risk of homelessness. This includes defense of illegal eviction actions, representation in unlawful housing subside terminations, substandard housing conditions cases, illegal utility shutoffs and mortgage foreclosure defense.

Additionally, Prairie State provides legal information and self-help materials about current housing issues to the public. Our project attorneys prepare legal materials for self-represented litigants in eviction and foreclosure court; educate our social service agency partners about housing issues and do community outreach to the public. Currently, we do a Facebook live event on our Prairie State Facebook page each Thursday at noon to share up to date information about the eviction moratoria and other housing information. All who visit our Facebook page can access this information weekly. Each Friday, we have a Spanish translation of the previous day's program available on our page too.

In 2020, we represented 480 Lake County households who came to us for help with legal matters involving their home or homelessness.

The legal services Prairie State proposes to provide in PY 2021 through the Fair Housing Project and our Legal Advocacy Homelessness Prevention Project directly address three of the four priority needs identified in the Lake County 2020-2024 Consolidated Plan; ending homelessness; inclusive growth and housing accessibility. Prairie State has a proven record of accomplishment and strong collaborative relationships with other social service organizations and local government agencies that provide assistance for low-income members of our community, people with disabilities, survivors of domestic violence and other at-risk populations.

We thank the County for its continued support of Prairie State Legal Services' work in Lake County, and for recommending keeping the funding levels the same in this proposed amendment to the plan. Community Development Block Grant support has been crucial to our capacity to meet the legal needs of low income homeowners and tenants and to our ability to leverage other state and federal funding for our housing work.

Tier 2 funding recommendations, which projects could possibly receive funding should other projects not require their total grant amount, not progress as needed or fail, or should Community Development realize project income from past years' projects, were also presented. Staff asked the ARC commissioners to provide guidance should any additional funds become available and received HCDC consensus on the presented recommendations. Brenda O'Connell stated that approval of Tier 2 funding re-allocation grants would always return to the HCDC for approval.

Irene Marsh-Elmer, Housing Grant Administration Specialist, read the written public comments into the record. They were as follows:

Donna Drinka of Catholic Charities:

Thank you very much for your consideration in renewing our submitted Lake County ESG application for our Catholic Charities' Rapid Re-housing Program. This past year, we utilized our Lake County ESG funds to provide housing case management services to 16 households (29 family members) who were experiencing homelessness. During this time, we assisted 13 families in securing permanent housing, provided budget counseling, advocacy with landlords, on-going case management services, community linkage, and access to our food pantry. One of the most exciting parts of our job is to watch our program participants receive the keys to their new apartment – at that particular moment their face is covered in pure joy. With continued Lake County ESG funds we are able to provide homes to those who lack this basic need and give each household a sense of pride and a potential new beginning.

Ashley Styx of Catholic Charities:

Catholic Charities' Emergency Assistance Program would like to thank the Board for their support of our Emergency Assistance Program through CDBG Homeless Prevention funds. Last fiscal year, these funds allowed us to assist 19 households with obtaining or maintaining stable housing.

We have especially appreciated our collaboration with Lake County Community Development during Lake County's response to the COVID-19 Pandemic. From the COVID-19 funding (CDBG-CV, CHRP & CRF Finish Line Funds) we have received from the county, we have been able to assist an additional 252 households with obtaining or maintaining stable housing. We appreciate the chance to continue collaborating with the county while we all work together to address the ongoing needs of the residents as a result of COVID-19. Thank you.

Eddie Soto of Greater Waukegan Development Coalition (GWDC): Thank you for allowing us to provide public comment.

GWDC's mission is to foster economic development in economically challenged communities. Since its inception in 2012 as "Greater Waukegan Development Coalition,"

we have grown from supporting development within the seven municipalities in and around Waukegan, to working with over 50 municipalities and hundreds of businesses.

As an independent 501(c)3 not for profit economic development corporation, our core activities have increased from our core three: supporting and incubating core businesses; pursuing transformative real estate development projects; and facilitating foreign direct investment, to also include through the Lake County Tech Hub operating as a base of information and assisting the community with direction and introductions to local resources including health and wellness services and vaccine site updates.

In order to support and incubate core businesses, in 2014 we launched the Lake County Tech Hub and Business Incubator (LCTH). In 2016 we worked with the City of Waukegan to acquire our 8,000 square foot co-working and training facility at 13 N Genesee Street in Waukegan. In 2018 we received the first in a series of CDBG grants to help aid local Low to Moderate Income underserved and unbanked companies apply for micro lending.

In August, 2019 we hired Eddie Soto, a former SBDC Lake County Certified Advisor with 12 years of experience, to become the Director of the Lake County Tech Hub. Since joining us, Eddie has worked with well over one-hundred companies providing consulting on numerous business initiatives. Furthermore, he leads GWDC INVESTS, a working group of 10 loan officers from both traditional and non-traditional financial institutions. This group connects quarterly to discuss how we can aid local MWBEV businesses and the unbanked to gain access to capital.

Now with over 32 million people out of work and a protracted return to normal, we believe that business support and online video consulting services will be in high demand. In addition to our access to capital programs, Lake County Tech Hub has an active roster of mentor business owners who have been through tough times before and are ready to help.

Eddie Soto, Director of Lake County Tech HUB recently presented as an invited speaker to Waukegan Chamber of Commerce's "Wake Up With Waukegan" where he was able to share the LCTH experience in being a services resource to our community. He has also accepted an invitation from Wintrust to present a webinar on "Virtual Networking For Business" with over 120 presently registered to attend. With Lake County's support, we greatly appreciate the responsibility to continue to help build and develop resources and businesses to support our community, especially during these trying times.

We stand ready to aid the County should they ask more of us. We are here to serve.

Joint resolution approving the Program Year (PY) 2021 Video Gaming Revenue grant funding recommendations in the amount of \$713,260.

- The Lake County Board annually acts on the Video Gaming Revenue (VGR) award
 recommendations that are developed on the basis of the VGR policy. The policy
 outlines procedures for: capturing video gaming administrative, legal, and
 enforcement costs; and evaluating and possibly funding social programs, projects
 (excluding capital improvements), and/or services that benefit Lake County residents.
- The Policy specifies that periodic revisions may be made by the County Board through periodic review of the Policy. Most recently, at its November 2020 meeting, the County Board amended the policy to provide ongoing, dedicated funding for 211 services. This funding is to be set aside from the competitive award process.
- In January 2021, Community Development received applications for \$713,260 in available VGR funds.
- On March 10, 2021, the Housing and Community Development Commission (HCDC) approved VGR funding recommendations detailed in the attached memo, totaling \$713,260 for the following:
 - o 211 information and referral services;
 - Gambling education and outreach;
 - Gambling addiction services;
 - Financial literacy services; and
 - o Behavioral health services.

Brenda O'Connell, Community Development Administrator, thanked the community partners who have diligently worked to continue helping our citizens during the pandemic. She stated that she looks forward to the continuing collaboration with Lake County's partners. She also thanked the HCDC members for their assistance. Staff is working hard to launch the Federal Emergency Rental Assistance (FERA) program. A Request for Proposals has been sent to community partners requesting entities to help administer the program. She added that the American Rescue Act, which will provide addition funds to help Lake County's citizens, was passed by the House of Representatives and is expected to be approved by the President. Along with other funding, approximately \$6,000,000 in HOME funding would be available to help provide more permanent solutions to address homeless needs.
