
On behalf of the local government members of the Barrington Area Council of Governments (BACOG), thank you for the opportunity to comment on the proposed amendments to Chapter 151 of the Lake County, Illinois, Code of Ordinances relating to the regulation of adult-use cannabis businesses (AUCBs) in unincorporated areas of the County.

BACOG urges you to reject the proposed zoning amendments that would permit AUCBs in unincorporated Lake County. The Illinois Cannabis Regulation and Tax Act empowers local governments to prohibit such businesses. This recognizes that whether to authorize an AUCB in a specific location is fundamentally a decision that should be made by officials in the immediate surrounding area potentially impacted by a potential AUCB. Even decision-making at the county level is too broad to fully respect the diversity of opinions on this issue. It is evident on the map provided on your website, "Map of Adult Use Cannabis Regulation by Municipality," that there is not a consensus across the County as to whether AUCBs should be permitted. Adopting a county-wide policy for unincorporated areas would disregard this important fact. Each of the BACOG municipal members has undertaken a deliberative process to determine the treatment of AUCBs that is appropriate for their residents. Placing AUCBs adjacent to communities that have chosen to prohibit them goes against the expressed will of those residents. Placing AUCBs adjacent to communities that have decided to allow them stands to unduly divert much needed revenues from those municipal coffers.

We are particularly concerned about the potential for locating AUCBs in unincorporated areas within 1 ½ miles of any municipal border. Properly authorized AUCBs must contend with a persistent illegal market for cannabis products. Municipal police forces must be ready to respond in the event this competition subjects the AUCBs to burglary, theft, or other criminal activity that extends into their jurisdiction. We respect the dedication and service of the Lake County Sheriff's Department, but also know that municipalities must plan and budget for the cost of helping to respond to issues arising at AUCBs near their borders. Accordingly, these municipalities, rather than the County, should decide whether these businesses may be located near their jurisdiction.

We appreciate the deliberative process you are undertaking with respect to the initial decision regarding AUCB regulation. As you continue to evaluate this proposal, BACOG strongly encourages you to engage directly with those municipalities and townships most directly affected. We also encourage you to continue this approach in the future. If this issue is ever reconsidered, we hope the County will commit to working with affected municipalities and townships early in the process to address the impact on our communities.

Dear Lake County Public Works, Planning and Transportation (PWPT) Committee,

My name is Barbara de Nekker and I am a Grayslake resident. I am writing in regards to your consideration of retail marijuana dispensaries in unincorporated areas of Lake County. For the past 20 years, I've worked in the field of drug prevention on a local, regional and national level. My goal has been to protect youth's growing minds and bodies by preventing or delaying youth initiation of smoking, drinking alcohol and marijuana use.

I also lived 3 years in the Netherlands, around the corner from a marijuana shop. On top of some of the proven research outlined below, I can attest that there are additional externalities that are hard to quantify. Just like in Illinois, marijuana shops in the Netherlands are not allowed to sell to minors, but somehow, teens still got their hands on it. Perhaps the store sold it to them anyway, perhaps they had fake identification, perhaps older siblings/friends purchased it for them or perhaps they asked a random adult to purchase it for them, often known as a shoulder tap. Teens would end up in the garage and lobby of our apartment building using marijuana. They set fire to our mailboxes and tampered with the throttle of our car.

In my work, I've read large portions of the 600 page state marijuana law and identified some concerns that unfortunately cannot be prevented or addressed by local jurisdictions. While the state law allows local jurisdictions to regulate the number and zoning of marijuana establishments, the county and municipalities cannot regulate anything else once they are allowed.

The county could not regulate the THC content of marijuana products, even though research shows a clear link to increased risk of psychosis. A 2019 study published in the respected Lancet journal looked at THC-induced psychotic episodes across 11 cities in 9 different countries. They found that capping THC content at 10% would prevent 12% of first-time psychotic episodes. The Netherlands, known for being tolerant of "soft drugs," considers marijuana over 15% THC to be a hard drug. Unfortunately, the state of Illinois set a higher tax bracket at 35% THC, making it unlikely they will ever limit THC to less harmful levels. Illinois is already seeing a rise in psychosis since legalization. The chief medical officer of Silver Oaks Behavioral Hospital in New Lenox was quoted in the Northwest Herald saying that marijuana-induced psychosis increased four-fold.

This impacts me personally, as my childhood best friend was diagnosed with schizophrenia, likely triggered by a marijuana-induced psychosis. It would be difficult for any friend or family member to deal with the psychosis of a loved one, particularly when they were under the false assumption marijuana was a harmless drug.

Additionally, the county cannot regulate products and flavors sold at the dispensaries. As proven by the vaping industry's success in hooking a new generation, flavors are key to initiating young people to addictive products. As a result, the federal government banned flavored vape cartridges in early 2020 and in September 2020, the City of Chicago banned all flavored vapes as a way to reduce youth initiation. And yet, flavored THC vapes remain available. In Lake County, one can find flavored THC vapes such as Lemon Slushie, Blue Zkittles and Bombsicle, all of which have THC content of 77% - 86%. On top of this, the marijuana industry also produces products such as pink passion popsicles with 25 mg THC each (equivalent to 2 – 3 marijuana joints), peanut butter chocolate bars with 100mg of THC and "Strahhhberry" gummies with 10mg THC each. Again, all of these products are available in Lake County. (See attached.)

The country of the Netherlands, the province of Quebec and the state of Vermont all allow adults to use marijuana but banned advertising the drug. While the State of Illinois has some restrictions regarding advertising, tobacco and alcohol advertising are more strictly regulated. The state also pre-empted local jurisdictions from any of their own advertising regulations. Because marijuana is now a for-profit business in Illinois, it is logical that the amount of advertising would increase with every marijuana establishment. While they of course are not allowed to market to minors, the vaping industry is also not allowed to market to minors. And yet, in 2019 the Lake County State's Attorney filed a lawsuit against them for illegally marketing to minors. Some school districts in Lake County have since signed on to that lawsuit.

Will the marijuana industry try to do the same? Well, the marijuana chain Zen Leaf now has a billboard along the highway south of Chicago featuring a raccoon wearing sunglasses with his arms up in the air like he is partying. He is very similar to the character Rocket from the very popular superhero movies Guardians of the Galaxy. This raccoon is also featured on a sandwich board outside the Zen Leaf location in Highland Park and in digital advertising (see attached). While not a cartoon, he is likely more appealing to teens than Joe Camel ever was.

Lastly, a 2019 study showed that young people (18-22 years of age) living within 4 miles of a marijuana dispensary are more likely to use the drug and use it more often. Because the proposed zoning would limit the stores to areas in and around Grayslake, Lake Villa, Lindenhurst, and Grant Township, this puts youth in those areas at higher risk for drug use.

Thank you for considering these facts. Please let me know if I can provide you with any further research or information.

(Members of the ZBA at the virtual hearing last night were expressing relief when they were shown that very few locations would be eligible according to the proposed setbacks. I am concerned that most of the members will be happy to vote to allow cannabis businesses as long as their districts are not greatly affected.) 2. Have you seen the potential sites for dispensaries in our district mapped out? (I am relying on my own use of the interactive mapping tool with the buffers indicated in the proposed changes to the UDO because it was difficult to see our area in the presentation at the hearing, but it appears that several of the locations eligible to have dispensaries are along Petite Lake, Grass Lake, and Grass Lake Road. Among these seem to be parcels corresponding to existing bars, marinas, and I believe a small resort. I can attest that there are already too many accidents on Grass Lake Road due to impaired driving, recreational and bar traffic, and some dangerous curves.) 3. Why are buffers for dispensaries proposed to be only 250 feet from residentially zoned properties where children actually live, while buffers of 500 and 1,000 feet are proposed where children attend daycare or school? (Even increasing buffers for residential properties to 500 feet would improve safety and better protect the character of the area, for people living along Grass Lake Road, for example. Buffers of 1,000 feet would eliminate most potential locations, at least the most inappropriate ones, and protect a majority of the Chain.) 4. Why are buffers being proposed for parks and forest preserves but not bike paths? (I know that Grass Lake Road has recently been improved with bike friendly shoulders in expectation of the future extension of a bike path continuing to Chain O' Lakes State Park. I voted against allowing recreational marijuana in our 60002 Mary D. municipality. It passed 4-3 with Mayor Hanson voting in favor to break the tie. I had multiple concerns regarding allowing cannabis in Antioch not the least of which was increasing the incidence of DUI albeit with a different substance. Further, the proximity to the WI border stands to potentially recreate the "Blood Border" between the two states which existed when the alcohol drinking age in WI was 18 years of age. I also do not believe in the potential of a dispensary increasing other retail sales in Antioch. District 1 has the largest unincorporated area in Lake County. I would ask the county board to consider the ramifications of allowing dispensaries and other types of cannabis businesses be unfettered within our community. I believe that the County Board should vote against allowing cannabis businesses in the unincorporated areas of Lake County. The only saving grace of the decision that was made here in Antioch is that there is only one dispensary allowed. I would encourage the County Board members, should they make the decision to allow cannabis businesses in the unincorporated areas, to restrict the number to one in each district. That would put our very large unincorporated area on the same level playing field as those districts that have either no or very small unincorporated areas. To do otherwise would place a greater burden on our resources.
