Worldwide, the COVID-19 pandemic continues to break daily records, even as the pace of vaccinations accelerates in some countries.

Lake County has had over 60,250 confirmed COVID-19 cases and over 974 deaths throughout the pandemic. Over 1 million tests have been administered. Lake County's recovery rate is 98.3%.

In Region 9, Lake and McHenry counties, the testing positivity rate rose in early April, peaked on April 11 at 4.7%, and has gradually decreased over the past month. ICU bed availability has been declining. Hospitalization rates have been increasing over the past 30 days and are similar to levels seen last summer.

From the end of March 2021 to April 18, 2021, the incidence of COVID-19 among those ages 14-18 has doubled. On average, the Health Department receives over 30 notifications per week from high schools reporting cases or close contacts among high school-aged individuals.

In the past two months, there were four outbreaks among high-school aged individuals: three related to sports teams and one to a social gathering. Outbreaks are defined as five or more cases linked to a specific event or group.

While young people are at lower risk of severe illness from COVID-19, spread among this younger population can lead to infections in many people across our communities.

The Pfizer COVID-19 vaccine is currently available to those ages 16 and older and may be authorized for ages 12-15 as early as this week.

We have not reached herd immunity and people of all ages should continue practicing the 3Ws – wear a mask, wash hands, watch your distance – and get vaccinated as soon as you can.

Pandemic Travel Advisories

With summer quickly approaching and vaccination rates increasing, many people are eager to travel. Additionally, many countries and states are loosening restrictions for visitors.

On April 19, the U.S. Department of State issued a Travel Advisory Update classifying approximately 80% of countries worldwide as "Level 4: Do Not Travel."

The Centers for Disease Control and Prevention (CDC) recommends delaying travel until you are fully vaccinated because travel increases your chance of getting and spreading COVID-19.

Once you are fully vaccinated, you can travel within the United States, but you should follow local guidelines and consider levels of community transmission when selecting a travel destination.

International travel poses additional risks, and even fully vaccinated travelers are at increased risk for getting and possibly spreading new COVID-19 variants. Pay close attention to the COVID-19 situation at your destination before traveling. If you are not fully vaccinated, you should get tested for COVID-19 before and after travel. Fully vaccinated people do not need to quarantine after returning unless they have COVID-19 symptoms.

COVID-19 Vaccination Updates:

Safe and effective COVID-19 vaccines are an important tool that will help us put an end to the pandemic. Lake County's goal is to fully vaccinate 80% of our population to achieve herd immunity from COVID-19. This amounts to 560,000 people receiving the vaccine. On April 30, the Health Department reached an important milestone, administering its 100,000th dose of the COVID-19 vaccine at our various vaccination sites. So far, over 500,000 doses of the COVID-19 vaccine have been administered to Lake County residents. Over 30% of Lake County residents are fully vaccinated, including 72% of our seniors ages 65 and older.

Vaccine supply has increased dramatically in the past month, and it is easier than ever to get your COVID-19 vaccine. All Lake County residents are urged to get vaccinated as soon as possible. To schedule a vaccination appointment at a Lake County vaccination site, visit AllVax.lakecohealth.org or call (847) 377-8130.

Many vaccination sites, including the Lake County Fairgrounds and our Regional Vaccination Site at 102 W. Water Street, Waukegan, are now offering walk-ins with no appointment needed. For locations, hours, and other details, please visit lakecountyil.gov/vaccine.

AZ Polymers Breaks Ground in Gurnee, Creates New Jobs

AZ Polymers, an advanced manufacturer of high-quality specialized plastic substrates, joined state and local officials (including Lake County Board Chair Sandy Hart) in breaking ground and celebrating plans to develop a new headquarters and manufacturing hub in Lake County. Sahil Aggarwal (pronounced Agg-Ahr-Wall), the owner and CEO of AZ Polymers and the President of Gurnee's United Plastics, is a true homegrown talent—he received his education from Warren High School and the College of Lake County.

Life Science Leaders Join Forces to Fund Zion Vaccine Clinics
Lake County Partners has been working closely with the Department of Health to monitor vaccine needs in the county and determine opportunities for business support. In response to an identified need in Zion, Lake County Partners assembled a powerful partnership between Horizon Therapeutics, Lundbeck, Takeda and iBIO to fund and launch two vaccination sites in the city.

The clinics, located on select days at the Zion-Benton Township High School New Tech Campus and at the former K-Mart plaza in Zion, are now providing free vaccinations to community members aged 16 and older and further ensuring vaccine equity in the county. 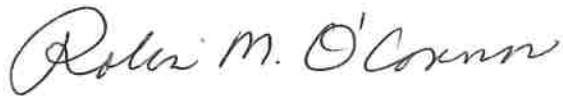
