Chair Hart stated that the following topics would be discussed: number of County Board Members; Members elected by district or at-large; Number of districts and if single-member or multi-member districts; method of electing County Board Chair; and method of compensation.

After a thorough discussion, the Committee's consensus was to: reduce the number of County Board Districts to 19, remain at single-member districts, elect a County Board Chair from within the County Board, and for County Board Members to be compensated by an annual salary.

Chair Hart explained that in 2011, the direction from the state was that all districts needed to have equal populations; whereas, in 2012, the state legislature edited the language to read that the population of all county board districts needed to be "substantially equal."

Attorney Friedman noted that the goal is to try to get the district populations to be as substantially equal as possible.

Keith Caldwell, GIS Manager, presented a map pertaining to Lake County's African American population density, from the 2020 Census. Mr. Caldwell noted that the Zion and Waukegan areas seemed to have the largest populations of African American individuals in the County.

Mr. Caldwell then presented a map and table that compared the populations of all municipalities within Lake County, based on the 2020 Census data. Mr. Caldwell noted that the largest population decrease from the previous census took place in Bannockburn, while the largest population increase was in Volo.

Steve Carlson, former County Board Member, made a public comment regarding how the mapping process was shown to the Board in the past.
