CHAIR'S REMARKS

Board members may have noticed that the county's declaration of emergency due to COVID expired on December 15, 2022 and is not on our agenda today. This declaration had been in place since March 13, 2020. The State of Illinois, along with some other states, such as California and Texas, continues to declare COVID 19 an emergency. After speaking with emergency management manager Dan Eder, staff recommended to start off the new board term without the declaration of emergency. Staff continues to work with outside groups on distribution of PPE and other activities related to the covid outbreak. This does not require the EOC to be active. If cases do spike and public health professionals think we need to reinstate it, I will bring it forward to the board for a vote at that time.

Regional Kickoff for the Chicagoland initiative: In early January, Gary Gibson, Kevin Considine, and I attended the formal announcement of the formation of the Greater Chicagoland Economic Partnership which includes the City of Chicago and the Counties of DuPage, Kane, Lake, Will, McHenry, Cook and Kendall. The Greater Chicagoland Economic Partnership will focus on promoting the region's many assets, including

extensive freight infrastructure, diverse talent, strong exporting industries, and world-class institutions of innovation, research, and culture. World Business Chicago (WBC) will manage the new Chicagoland Partnership and will complement existing municipal and county programs, like Lake County Partners. I really want to thank Kevin Considine, President of Lake County Partners, for his leadership in this important initiative. Without him and his counterpart in DuPage, I really don't think it could have come together.

I was in Springfield last week with Esiah Campos, Jennifer Clark, Gina Roberts, Sara Knizhnik and Jessica Vealitzek for several inaugurations of statewide elected officials as well as for our Lake County delegation. While there, Gina Roberts and I were able to attend the final debate in the House regarding the Assault Weapons Ban, and were able to watch Governor Pritzker sign the bill. Our own new board member Sara Knikhnik. was included in the select group of people who were able to stand behind the Governor, along with Senator Morrison, Representative Morgan, and Rep. Didech as they were strong advocates and proponents of the bill. I want to thank Members Frank and Parekh for their work in insuring we added language to our legislative agenda last fall to advocate for an assault weapons ban. Gun violence affects all of us, whether we live in North Chicago, Highland Park, Barrington, or Antioch. I look forward to continuing the conversations and hearing from experts about gun violence during our upcoming COW meetings and what we can all do to make a difference to keep our communities, and our county safe.

Thank you to Facilities: I want to thank all our outstanding and extremely dedicated employees who, over the holidays, spent time away from their loved ones to provide necessary services to our residents during the significant winter storm that swept through the area. As we all know, Lake County steps up no matter the time of year, even during the holiday season, to serve. I can't tell you how proud our board is of our teams that went above and beyond and continue to do so, each and every day.

From working around the clock to clear snow and ice, providing emergency response, timely reporting of weather and road conditions, to ensuring water and sewer service, and communicating real time safety information to residents, our teams met the challenge. And finally, thank you to all the crews that worked to make our facilities operational for business on January 2, especially after the bitter cold caused multiple sprinkler line breaks that led to subsequent water removal, cleanup, and repairs in the Lake County Court Atrium, and the 2nd and 3rd floors in the State's Attorney's Office, and the Depke Juvenile Complex Center.

Thank you again, for your service and making a difference for our residents. It is because of you that Lake County is the best place to live, work, and do business.

Coronavirus (COVID-19) Updates

As of January 12, 2023, Lake County has had over 172,893 confirmed COVID-19 cases and 1,503 deaths throughout the pandemic. Lake County's recovery rate is 99.2%. Lake County has recently returned to a "medium" community level along with 45 other counties in Illinois. As of January 6, 2023, 28 Illinois counties are currently at "high" community level.

When a county is at a "medium" community level, the CDC recommends:

Wearing a mask if you have symptoms, test positive, or have been exposed to someone with COVID-19 and when on public transportation.

Staying up to date with COVID-19 vaccines.

Getting tested if you have symptoms.

Talking to your healthcare provider if you are at higher risk of severe illness and in need of taking additional precautions.

Coronavirus (COVID-19) Vaccine Updates

The bivalent COVID-19 booster is available throughout Lake County and is recommended for everyone ages 5 and up who are fully vaccinated.

As of January 4, 2023:

Over 268 million people, or 80.9% of the U.S. population, have received at least one dose of a COVID-19 vaccine.

Over 229 million people, or 69% of the U.S. population, are fully vaccinated.

Over 48 million people, or 15.4% of the U.S. population, have received the updated bivalent booster dose.

Nearly 87.2% of all eligible Lake County residents, ages 5 years and older are fully vaccinated.

Flu Updates

Seasonal influenza activity is high and continues to increase across the country.

There have been signs that the 2022-2023 flu season in the U.S. could be severe as flu hospitalizations are rising and are higher than usual at this point in the season.

Flu is only one of several respiratory illnesses circulating, including RSV and COVID-19.

The best way to protect against flu is by getting a flu vaccine.

Everyone 6 months and older should get a flu vaccine every year.

If you or your child begin showing symptoms consistent with flu, contact your healthcare provider and ask about testing and treatment.

While many children and adults recover from the flu with fluids and sleep, a doctor may prescribe an antiviral medicine for someone who is very ill or those who are at risk for more serious symptoms.

January is National Radon Action Month

Radon gas is the leading cause of lung cancer among nonsmokers, claiming the lives of approximately 21,000 Americans each year.

Radon is a naturally occurring gas with no odor or color. It can seep into your home through cracks or other holes in your home's foundation.

Nearly 1 out of every 15 homes in the U.S. is estimated to have elevated radon levels. Lake County residents should test the radon levels in their home during the winter months, when indoor radon levels are at their highest.

Testing for radon is easy, inexpensive, and the only way to know if your family is at risk of radon exposure.

The Health Department offers short-term testing kits for \$10.00, available at 500 W. Winchester Rd., Libertyville, or for \$13 by mail. The cost includes return postage, laboratory analysis and interpretation by Health Department laboratory staff. Test kits are also available from area hardware and building supply stores.

Lake County Partners Update.

LAKE COUNTY JOINS REGIONAL LEADERS FOR NEW PARTNERSHIP
Regional leaders recently joined together to announce the formation of the new Greater
Chicagoland Economic Partnership, a first-of-its-kind united effort including the City of
Chicago, Cook County, Lake County and the five other counties across metropolitan
Chicago. The goal of the initiative is to drive a regional economic strategy that will deliver
mutual benefits to partners, and strengthen Chicagoland's economic power in an
increasingly fierce competitive global market. Importantly, the agreement provides for a
no-poaching clause to support business retention.

The partnership will directly benefit Lake County by adding scale to LCP's business attraction efforts and enhancing LCP's data intelligence. It will also give Lake County equal footing and a seat at the table with other leaders in the region. The County Board has allocated funding in support of this initiative, and, there is sufficient funding in place from the partners to finance an initial three years of operation. Expect to hear more as the initiative rolls out in the coming months.

2022 ENDS ON A HIGH NOTE

Thanks to the support of investors like Lake County, LCP had a big impact on the local economy last year—playing a direct role in the creation of 419 new jobs, 112 retained jobs and \$202 million in direct capital investment, which was the highest investment number in five years. The 2023 pipeline is already full, with 28 projects focused on key industries such as advanced manufacturing, life sciences and energy/sustainability. Two projects that began last year crossed the finish line just this month; while LCP is not yet in a position to disclose the details, you can expect to hear more about these exciting wins soon.
