6.1 23-0287

Presentation and Discussion: Program Year 2023 (PY23) Proposed Funding Recommendations - U.S. Department of Housing & Urban Development (HUD), Lake County Affordable Housing Program & Video Gaming Revenue Grants.

Dominic Strezo, Senior Grant Manager, presented proposed funding recommendations for the Affordable Housing and Public Improvement Advisory Recommendation

Committee (ARC). Ten applications were received for the Public Improvement ARC grouped by clientele or area benefit and distributed to applicants scoring more than seventy percent. The Affordable Housing ARC recommended funding to proven housing programs: rapid rehousing; owner occupied rehabilitation; down payment assistance; community land trust; community housing development organization. In addition to proven programs, funding was recommended for landlord outreach education, six new construction projects, and three rehabilitation projects.

Damon Coleman, Senior Grant Manager, presented the Homeless ARC recommendations. Homeless grants are funded by the Emergency Solutions Grant Program and the eligible programs include outreach, emergency shelter, homelessness prevention, rapid rehousing, homeless management information, and administration.

Eric Tellez, Grant Manager, presented Public Services grant recommendations that include the Community Development Block Grant (CDBG), and Video Gaming Revenue. The Public Services ARC recommended funding to proven housing programs: homeless prevention, homeless prevention, fair housing services, and housing legal advocacy. CDBG public service applicants were scored based on ConPlan needs and priorities. Video Gaming Revenue applications were scored based on the following priorities: assessment, education, and outreach; clinical gambling addiction services; non-clinical gambling addiction services; and behavioral health services.

US Department of Housing & Urban Development (HUD) grants recommendations were based on last year's funding level and final recommendations will be presented at the next meeting after our final funding is determined by HUD.

PUBLIC HEARING - Program Year 2023 (PY23) Funding Recommendations
[1] This public comment is submitted by Dr. Dora Maya, President & CEO of Arden Shore Child & Family Services:

On behalf of the children and families Arden Shore serves, please accept my gratitude for everything the Lake County Community Development staff and the members of the Commission do to make our shared community a healthy and safe place to live, work, and play.

Today, funding to support Arden Shore's Behavioral Health internship program will be considered for recommendation. Last year, Arden Shore's dedicated team provided expert care and resources to more than 1,850 children and adults-keeping families healthy, safe, and together. Since your first investment in a dedicated supervisor position for our internship program in 2018, Arden Shore has trained over 70 interns and now actively collaborates with 19 local master-level programs. This year to date, 77% of behavioral health clients reported a meaningful reduction in their presenting problems, 83% of clients demonstrated an improved functioning level, and 93% of clients have shown an improvement in the assessment of life areas.

The growth of Arden Shore's Behavioral Health program since the onset of VGR funding

has helped to attract additional investments, including:

- •Funding for a full-time Spanish-speaking Behavioral Health counselor, further increasing our capacity to serve the English & Spanish-speaking community regardless of ability to pay;
- •Funding for intern stipends to reduce students' economic barriers to completing their degree requirements; and
- •General operational support most notably from the John and Kathleen Schreiber Foundation, Healthcare Foundation of Northern Lake County, and AbbVie Foundation.

According to data from the Kaiser Family Foundation, American Psychological Association, and NAMI Illinois, there are only 14 behavioral health care providers for every 10,000 Illinois residents. By 2030 Illinois is predicted to have a shortage of more than 3,300 providers. The Healthcare Foundation of Northern Lake County's 2022 community needs assessment echoed these concerns and recommended investment in behavioral health workforce pathways, particularly for persons of color and for the Spanish-speaking community.

Your continued investment in Arden Shore's Behavioral Health Internship program directly increases the accessibility of quality behavioral health services, ameliorating the immediate lack of Medicaid Behavioral Health provider choice in Lake County while building a workforce prepared to serve a culturally and linguistically diverse community for years to come.

6.3 23-0288

Joint resolution approving the Program Year (PY) 2023 Lake County Affordable Housing Program (LCAHP) grant awards.

- In December 2022, Community Development staff received applications for eligible affordable housing programs and projects.
- The available affordable housing funding includes \$281,000 of LCAHP Funds. The
 Fiscal Year (FY) 2023 budget for Affordable Housing is \$270,000. In addition to the
 budget, the recommended programming includes reallocation of a project from 2019
 that has been cancelled in the amount of \$10,000, as well as \$1,000 in program
 revenue from Prairie View Apartments.
- On February 27, 2023, the Housing and Community Development Commission voted to recommend LCAHP funds to the following:
 - Catholic Charities \$91,000 for rapid rehousing;
 - Community Partners for Affordable Housing \$40,000 for the support of housing assistance programs; and
 - Lake County Housing Authority \$150,000 for a Landlord Outreach Program.
- Lake County Community Development receives a transfer of \$30,000 from the General Fund to administer this program separate from the Affordable Housing budget.

Joint resolution approving the Program Year (PY) 2023 Video Gaming Revenue grant funding recommendations in the amount of \$640,000.

 The Lake County Board annually acts on the Video Gaming Revenue (VGR) award recommendations that are developed on the basis of the VGR policy. The policy outlines procedures for: capturing video gaming administrative, legal, and enforcement costs; and evaluating and possibly funding social programs, projects (excluding capital improvements), and/or services that benefit Lake County residents.

- In December 2022, Community Development received applications for \$913,884 in available VGR funds.
- On February 22, 2023, the Housing and Community Development Commission (HCDC) approved VGR funding recommendations detailed in the attached memo, totaling \$640,000 for the following:
 - 211 information and referral services;
 - o Gambling education and outreach;
 - Gambling addiction services;
 - Financial literacy services; and
 - Behavioral health services.

Presentation and Discussion: HOME-ARP Allocation Plan as the Sixth Amendment to the Program Year 2021 (PY21) Annual Action Plan (AAP).

Dominic Strezo presented the HOME-ARP Allocation Plan. HOME-ARP is awarded through HUD HOME Investments Partnerships Program. HOME-ARP funds have four eligible uses production or preservation of affordable housing; tenant-based rental assistance; supportive services, homeless prevention services, and housing counseling; and purchase and development of non-congregate shelter. The current plan allocates all funding for the development of affordable rental housing. Preference will be given to supportive housing or projects with three or more bedrooms. The main driver of the plan is a HUD deadline next month. The plan will likely need to be revised as projects are funded.
