Presentation and Discussion: Program Year 2024 (PY24) Proposed Funding Recommendations - U.S. Department of Housing & Urban Development (HUD), Lake County Affordable Housing Program & Video Gaming Revenue Grants.

Attachments: PY24 Funding Recs

Brenda O'Connell, Community Development Administrator, reviewed the funding sources for Planning Year 2024 (PY24): Affordable Housing Program (AHP), Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), Emergency Solutions Grant (ESG), and Video Gaming Revenue (VGR).

Dominic Strezo, Community Development Grant Manager, provided funding recommendations for the CDBG public improvement applications that were all categorized as clientele benefit application type. These were capital projects for partners who serve eligible clientele. He continued with the Affordable Housing Program proposed projects and funding recommendations.

Before the homeless assistance recommendations were presented, Brenda announced that Catholic Charities has decided to make a strategic shift in their funding sources to reduce government contracts. The funding recommendations were drafted before the Catholic Charities' announcement.

Penni Raphaelson, Senior Grant Administrator, presented the ESG funding recommendations with eligible program components of Outreach, Emergency Shelter, Homelessness Prevention, Rapid Rehousing, Homeless Management Information System, and Administration. The \$30,000 recommended for Catholic Charities will be reallocated at a later date.

Penni Raphaelson presented recommendations for the CDBG Public Services Grants. Funding was recommended to proven housing programs, homeless prevention, fair housing services, and housing legal advocacy. The balance of the entitlement funds was scored based on ConPlan priorities that improve the homeless response system, assist people with special needs, and promote upward economic mobility. The \$110,000 recommended for Catholic Charities will be reallocated at a later date.

Eric Tellez, Senior Grant Administrator, presented the VGR recommendations. VGR applications were scored based on the following priorities: assessment, education, and outreach; clinical gambling addiction services; non-clinical gambling addiction services;

and behavioral health services.

Joint resolution approving the Program Year (PY) 2024 Video Gaming Revenue grant funding recommendations in the amount of \$755,000.

- The Lake County Board annually acts on the Video Gaming Revenue (VGR) award
 recommendations that are developed based on the VGR policy. The policy outlines
 procedures for: capturing video gaming administrative, legal, and enforcement costs;
 and evaluating and possibly funding social programs, projects (excluding capital
 improvements), and/or services that benefit Lake County residents.
- In December 2023, Community Development received application requests for VGR funds totaling \$829,100.
- On March 13,2024, the Housing and Community Development Commission (HCDC) approved VGR funding recommendations detailed in the attached table, totaling \$755,000 for the following: 211 information and referral services \$125,000; gambling education and outreach \$100,000; gambling addiction services \$100,000; financial literacy services \$14,000; and behavioral health services \$416,000.
