Lake County Partners continues to pursue an aggressive economic development agenda focused on Existing Business Support, Business Attraction and Expansion, and Partner Engagement.

During the month of May, Lake County Partners officially kicked off the Comprehensive Economic Development Strategy project by hosting the first Strategy Committee meeting. The Comprehensive Economic Development Strategy project will result in a blueprint for economic development initiatives over the next 3-5 years. ### Medicaid Update:

- As many of you know, the Illinois Medicaid system was on the brink of collapse, with a \$2.7 billion hole in the FY 2013 Medicaid budget plus \$1.9 billion in unpaid Medicaid-related bills at the end of the current FY 2012 (through June 30). Without resolving the Medicaid crisis this spring, the program would have continued to impact the rest of the state budget, limiting the ability to fund critical state priorities, including education, public safety and the capital construction program.

- The proposals were developed after a review of the entire Medicaid program by the bipartisan Legislative Medicaid Advisory Committee.

- The legislation scales Medicaid to fit existing appropriations through spending reductions, utilization controls and provider rate cuts.

- The Health Department and its professional associations are analyzing the impacts of the new massive overhaul of the Illinois Medicaid system. The legislation is 450 pages and impacts 62 areas. We will bring you further information in the future.
