PY2015 Affordable Housing Application Round Presentation, Deliberations and Allocations - Discussion and Recommendation

Ms. Jodi Gingiss spoke about PY2015 funding availability and the Consolidated Plan (CP) goals for housing; 1) Rehabilitation existing housing for affordable housing and special needs, 2) Develop new housing for affordability and special needs, 3) Assist people without a home, and 4) Subsidize housing for low- and moderate-income families. She then detailed the funding targets that had been set for each goal during the CP process. Ms. Gingiss informed the ARC members that the funding for the Emergency

Solutions Grant (ESG) program was greater than expected; therefore the monetary target for goal #3 would be fulfilled with ESG funds. She then called on each agency represented to give a brief explanation of their projects. The ARC members discussed the applicants' scores and the funds required to allow each recommended project to proceed to completion. Ms. Gingiss reminded the ARC that the HCDC had approved the retention of project funds, in the amount of \$2,000 per address, for payment of the federally-required environmental review and for construction inspections. The funding recommendations were as follows:
