Mr. Warner provided a brief overview of how the acquisition and demolition of structures is funded through a FEMA grant. The funds in part would go towards nine identified residents across the county. This is the continuation of a current program with IEMA and SMC is in

the process of going out to bid on a few structures in Gurnee. From SMC's experience 90% of buy-outs buy existing housing stock in the county. Discussion continued on the buyout proram mechanics, public benefit and details on the specific properties.
