7.4 15-0992

Joint resolution authorizing the acceptance of an Illinois Department of Transportation Sustained Traffic Enforcement Program (STEP) grant and the emergency appropriation of the grant amount of \$119,967.40 for fiscal year (FY) 2015 - 2016.

Dawn Wucki Rossbach, Lake County Sheriff's Office, informed the group this grant will allow the Lake County Sheriff's Office, to perform enforcement campaigns.

Sergeant Tom Struck, Lake County Sheriff's Office, added, the grant funds special D.U.I.

and seatbelt enforcement patrols, which deputies work overtime during the holidays to operate. In addition, this grant gives the ability to operate additional campaigns during a regular weekend not considered a holiday or special day, this gives the Sheriff's Office the ability to enforce seatbelt use and D.U.I. throughout the year.

Member Calabresa inquired as to how the sites for these campaigns are chosen. Lake County's Undersheriff, Raymond Rose, noted the intent is to choose sites with high traffic volume so the impact is more effective.

Chair Nixon also inquired about how the public will be notified, to which the Lake County's Sheriff, Mark Curran, added the fourth amendment requires the Sheriff's Office to notify the public when the campaigns will occur and will advertise the dates in the newspaper.

Joint resolution executing an intergovernmental agreement with the Village of Fox Lake for emergency and temporary law enforcement personnel assistance.

Lake County's Under Sheriff, Raymond Rose, informed the group that the retirement of the Fox Lake Police Chief and the passing of a police lieutenant added additional vacancies which the Fox Lake Police Department has requested the Lake County's Sheriff's Office to assist in hiring a new Police Chief and providing management to help stabilize the environment. The Lake County's Sheriff's Office will also assist with their policies, reorganization, and redeployment of resources. As a result, the Lake County's Sheriff's Office is asking the Fox Lake Police Department to enter into this contract, which will have the Fox Lake Police Department finance the services and the people hired, so Lake County is not financially impacted.

Deputy County Administrator, Amy McEwan, added that it is not the intent of the Lake County's Sheriff's Office to fill vacancies in other departments; however, this is an extenuating circumstance and the Sheriff's Office and the County Administrators Office believe this is appropriate.

Member Calabresa inquired on the announcement made regarding the grant received for body cameras and would like details on the process. Undersheriff Rose explained the Lake County Sheriff's Office applied for a federal grant to purchase the cameras to equip all deputies with the exception of the Jail. The Lake County Sheriff's Office will return during the budget hearings with more information.

Joint resolution authorizing a contract with Midwest Dock Solutions, Inc. of Crete, Illinois, and further authorizing assignment of that contract to Clark Construction Group LLC of Chicago, Illinois, as Construction Manager at Risk (CMAR) for the overhead door work for the Lake County courthouse expansion project in the amount of \$59,000.

Matt Guarnery, Robison Guarnery, Inc., presented on three purposed contracts recommended for approval, and reminded the group these purposed contract all fall under the preapproved GMP. One of the contracts is for construction hoist and has been awarded to USA Hoist Company, Inc. of Chicago, Illinois, the next award is for the accordion doors, awarded to Konematic, Inc., of Naperville, Illinois, and the final award is with Midwest Doc Solutions, Inc., of Crete, Illinois, for the overhead door work. Mr. Guarnery, reviewed the GMP status and added there is \$9,000,000 left to procure.

Member Calabresa would like to know what type of work is left to procure with the \$9,000,000. Mr. Guarnery, informed the group the largest awards would be millwork, and drywall, there are also other awards such as landscaping and door hardware.

Joint resolution authorizing a contract with Wight Construction Services, Inc. of Darien, Illinois, for general contracting services required for construction of the Phase I expansion of the Robert W. Depke Juvenile Justice Center in the amount of \$12,816,166.25.

Kurt Schultz, Finance and Administrative Services, presented a brief history on the Depke Juvenile Justice Center expansion project. The Executive Justice Council approved the general contracting recommendation for the first phase of the project to Wight and Company in September 2015, featuring a new building addition which includes a new courtroom, administrative court support functions, and office space for the States Attorney, Public Defender, Clerk of the Circuit Court, and Court Security. The first phase also includes necessary site infrastructure improvements for future expansion and renovation phases recommended by the master plan released in June 2002.

Member Hart expressed her concerns as to why an expansion is necessary. Mr. Shultz informed the group the expansion is to decompress the space currently being used by adding 38,000 square feet. Gary Gordon, Finance and Administrative Services added that the facility was originally a rehabilitation center and not meant for the use of a juvenile justice center.

Mr. Schultz, continued with the presentation of the second phase of the project which is not part of this award.

Member Cunningham shared her concern regarding, Wight and Company's ability to complete this project without the necessity of a change order. Mr. Shultz gave a brief profile on Wight and Company and also informed the group that Wight and Company has met all requirements during the bid process.

8. Executive Session

9. County Administrator's Report

Gary Gordon, Finance and Administrative Services, presented on the local and minority construction participation. Lake County currently has three contractors for the JOC contract and \$5,600,000 is the total amount awarded between the three contactors, 62 percent of the work being performed is by Lake County firms. The makeup of the workforce is 25 percent minority employees, and 55 percent of the employees live in Lake.

The court house expansion has had 14,000 hours worked, 14.5 percent of those hours were worked by minorities and 20 percent of the workers have been Lake County residents.

Clark Construction has reached out to 557 contractors and has received 82 bids. Clark Construction reached out to 46 local contractors and received 13 local bids, 21 women owned firms and received 5 bids, 35 minority firms and received one bid. Lake County has awarded 28 bids and 21 percent has been awarded to local firms and 7 percent has been awarded to women owned firms.

Discussion ensued regarding the construction participation.

Carol Calabresa reported that the State's Attorney's Office recenlty became owners of a therapy dog for the children's advocacy center,; and also noted the Text-A-Tip prgram kicked off this week and is hoping to report next month.

Member Paxton left the meeting at 11:57 a.m.
