Goal #8 Provide Welcoming Communities Mano a Mano - \$23,069

Goal #10 Provide Services for Job Stability Highland Park Community Nursery - \$30,000 Erie Healthcare - \$27,500 Black Chamber of Commerce - \$25,000 NiCASA – Mental Health - \$23,776
