Tobacco Cessation

Is quitting smoking one of your 2016 resolutions? The Lake County Health Department and Community Health Center's Tobacco Free Lake County (TFLC) program focuses on helping tobacco users quit.

A Certified Tobacco Treatment Specialist (CTTS) is available to counsel clients in a one-on-one, group or telephone setting.

Those enrolled in counseling are eligible to receive discounted Nicotine Replacement Therapy (NRT).

Quitting tobacco use is one of the most important health decisions an individual can make and research shows that behavioral support during the quit process, in combination with cessation medication increases an individual's chances of quitting and staying quit. In 2015 over 40% of the cessation clients reduced or quit their tobacco use. One client entered the program smoking 50 cigarettes per day (2.5 packs) and after cutting down, was able to quit completely.

Prescription Drug Disposal

Did you know Lake County has a prescription drug disposal network?

Through the efforts of the Underage Drinking and Drug Prevention Task Force and in cooperation with law enforcement the number of disposal boxes located at Lake County police departments has increased from 8 to 27.

Lake County residents can dispose of unused and/or unwanted prescription drugs at participating police departments.

Disposing of prescription drugs keeps our water supply healthy and helps to prevent prescription drug abuse.

Zika Virus

On Monday, February 1, 2016, the World Health Organization (WHO) declared Zika Virus an International Health Emergency. On Tuesday, February 2, Texas reported a person became infected with the Zika virus through sex. This is the first case of the illness being transmitted within the United States.

No other locally transmitted Zika illnesses have been reported in the continental United States, but cases have been reported in returning travelers.

Zika is not a new virus as it was first identified in 1947 in Uganda. Prior to 2015, the illness outbreaks occurred in areas of Africa, Southeast Asia, and the Pacific Islands. The virus is spread to people through mosquito bites. The main mosquito species (Aedes aegypti) that causes Zika infection also can transmit dengue, yellow fever and chikungunya viruses.

The main Zika carrying mosquito is not normally present in Lake County. However, the Lake County Health Department is keeping Lake County health care providers updated and is working with state and regional partners assessing risk.

The incubation period for Zika is 2 to 14 days and common symptoms are fever, rash, joint pain, and conjunctivitis (red eyes). The illness is usually mild with symptoms lasting from several days to a week. No vaccine or antiviral treatment is currently available, but both are under development by various pharmaceutical companies.

While not yet confirmed, there is a suspicion that Zika virus infection during pregnancy may cause microcephaly in the newborn. Therefore, the CDC recommends that pregnant women avoid travel to areas of ongoing Zika virus transmission. If travel is necessary, measures should be taken to prevent mosquito bites. Pregnant women returning from areas of Zika virus activity should consider testing to determine if they have become infected.

Lake County Partners' Business Outreach Program has resulted in specific feedback that has clearly identified the importance of a strong workforce needed for future economic development success. In order to address the talent and workforce needs of business LCP is facilitating cooperation among the key organizations in the County who all touch workforce and economic development... we're calling this the workforce ecosystem. The ecosystem combines the Workforce Development Department, the College of Lake County, Lake County Partners and more. Importantly, this streamlines efforts and increases the impact that we can have by integrating and enhancing the distinct value that each party brings.

Perhaps the best example of this is Little Lady Foods in Gurnee. The company has operations in both Elk Grove Village and Gurnee. One of their two facilities was going to be chosen for a \$10 million modernization (and 30 new jobs). Representatives from Lake County Partners, the Workforce Development Department, the College of Lake County, the Village of Gurnee and the Illinois Manufacturing Excellence Center worked together to assemble a creative solution for the company which revolved around Lake County's strong workforce and the College of Lake County's top-notch Mechatronics program. The Village of Gurnee closed the deal with a pledge to efficiently work through the complex permitting for the facility. True cross-organizational cooperation brought home a very

good win for Gurnee and the County.
