HIV Pre-Exposure Prophylaxis (PrEP)

HIV Pre-Exposure Prophylaxis, or PrEP, is the use of a daily single tablet medication individuals can take to protect them from acquiring HIV.

PrEP is to be used by individuals at highest risk of HIV infection such as partners of individuals living with HIV and those who engage in risky sexual behavior or needle sharing activities. It is a simple medication to take with few side effects and most insurances, including Medicaid, will cover the cost.

The providers at the Lake County Health Department and Community Health Center (LCHD/CHC) are trained to provide PrEP to any individual seeking it. Currently, LCHD's Community Health Center is the only clinic in Lake County routinely offering this prevention strategy to keep residents safe.

LCHD/CHC STI Program staff also assist patients in getting the medication paid for and working with patients to provide ongoing risk reduction counseling.

When used correctly, PrEP is 92% effective in preventing HIV acquisition. Each new HIV infection prevented saves the health care sector a lifetime cost of \$400,000.

Rx for Health-Walking in Nature is Saturday, August 13th at Lyons Woods in Waukegan The next Rx for Health walk is scheduled for Saturday, August 13th at Lyons Woods in Waukegan. The walk is open to all ages. Those 16 and younger must be accompanied by an adult. All walks start at 4 p.m. and range in length from one to two miles. These are rain or shine events and no pets are allowed (with the exception of service animals). Learn more at: www.lcfpd.org.

West Nile Virus Update

West Nile virus (WNV) activity in 2016 thus far has been average.

While no WNV positive birds or human cases have been confirmed in Lake County, 10 WNV positive mosquito pools (batches) have been documented in Lake County.

The first positive mosquito pool of 2016 was found on June 23rd in Highland Park, which is earlier than the average first positive date of July 14th.

The recent hot and dry conditions are more favorable to Culex mosquitoes, which transmit WNV. Weather conditions (e.g., rain and average temperatures) during the last week of July and first weeks of August may influence the WNV activity.

In Illinois, three human cases have been reported so far with no deaths.

Additional surveillance activities being conducted in Lake County and other portions of NE IL for the mosquitoes that can transmit Zika virus (Aedes aegypti and A. albopictus), have not found these species.
