Presentation of the Election Process.

Lake County Clerk Wyckoff provided a brief update on developments related to the November 8 General Election including that 1.) the In-Precinct Election Day Preliminary Injunction was stayed by the 7th Circuit Court of Appeals so there will be registration in the polling places on Election Day; 2.) the Clerk's Office has been gearing up for a high turnout on November 8 by recruiting additional Election Judges and encouraging Early and Voting By Mail; 3.) the Illinois State Board of Elections (SBOE) reported that a cyber intrusion into their voter registration data base has been thoroughly investigated, that 75,000 of their several million records were viewed but not altered or deleted, that no voter signatures or history captured, that security is enhanced and individuals affected (less than 100 in Lake County) will be contacted directly by the SBOE; 4.) the Election Day results will be reported first after the polls close, followed by Early and Vote By Mail votes and then write-in votes no later than November 14; and 5.) comprehensive registration and voting information can be viewed by going to LakeCountyClerk.info and then clicking on the "November 8 Election" icon.

2016 Lake Michigan Beach Season

The Lake County Health Department monitors over 100 swimming beaches in Lake County, including 12 Lake Michigan beaches.

In 2016, we had the lowest number of confirmed swim bans (n=39) at Lake Michigan beaches since 2002.

The most probable explanation is due to the higher Lake Michigan water level which has reduced the amount of beach area. Past research by LCHD has demonstrated that lower water levels expand the beach area which is more conducive to higher gull use. Increased gull populations are linked to higher bacteria concentrations in the water and consequently more swim bans.

Mosquitoes (West Nile and Zika)

The Health Department monitors and tests mosquito populations for West Nile virus, in coordination with our vendor (Clarke) and the Lake County Forest Preserves.

As of September 22, LCHD detected 121 positive mosquito pools (or batches) and two positive birds (crows). There has been one confirmed human case in Lake County.

The 121 positive pools represent the 3rd highest number since WNV was detected in Lake County in 2001. The Culex mosquito, which is the primary carrier of WNV in Lake County, tends to thrive in hot, dry summers. The summer of 2016 has been warmer, but wetter than average.

LCHD works with Clarke, municipalities and townships to assess mosquito abatement

needs based on mosquito trap results and mosquito larval inspections. Mosquito trapping ended on October 1st.

LCHD tests other mosquito species, beside *Culex*, to determine if they are carrying WNV. While *Culex* is the primary vector, these species may act as “bridge vectors” later in the season, meaning they can play a role in expanding the virus. In September, LCHD documented WNV in *Ochlerotatus trivittatus* for the first time in Lake County. This species tends to be more common later in the summer. WNV has not been detected in our most common species, *Aedes vexans*.

Both LCHD and Clarke set additional traps in the County to determine if the mosquitoes known to carry Zika virus were present. Neither potential Zika carrier, *Aedes albopictus* or *Aedes aegypti* have been found. A small number of *Aedes albopictus* have been found in the Chicago area, but the Zika virus was not detected in them.

Senate Public Health Hearing

On September 27, the Northern Illinois Public Health Consortium, of which the Lake County Health Department is a member, drafted and provided testimony to the Illinois State Senate’s Public Health Committee at the Subject Matter Hearing: Zika Virus and What’s being done by public health across Illinois to address it. Lake County Health Department staff created and provided talking points for the testimony.

The panelists updated the senators on Zika virus and the local, state and international prevention and response activities. They asked the senators to quickly appropriate anticipated funding from the federal government to address Zika virus and to maintain current funding levels from the Used Tire Fund and Local Health Protection Grant. Continued funding will allow local health departments to reduce mosquito populations, assist with identification of and screening for Zika and other vector borne infectious diseases and to educate Lake County residents on how to protect themselves and reduce their risk.

Rx for Health-Walking In Nature

The last Rx for Health walk of the 2016 season is Saturday, October 15th at Captain Daniel Wright Woods in Mettawa.

This free walk is open to all ages but those 16 and younger must be accompanied by an adult.

All walks start at 4 p.m. and range in length from 1 to 2 miles. These are rain or shine events and no pets are allowed, with the exception of service animals. To learn more, visit the Rx for Health page on the Lake County Forest Preserves web site.

Flu season is just around the corner. Getting vaccinated before flu activity begins helps protect you once the season starts. It takes about two weeks after vaccination for the body’s immune response to fully respond and for you to be protected.

The Health Department is offering the flu vaccine by appointment at the Immunizations Clinic at 2303 Dodge Avenue in Waukegan. However, the Health Department is just one of several locations offering the flu vaccine. It is available at retail clinics, pharmacies and through individual healthcare providers.
