in the Stormwater Management Commission (SMC) budget (Fund 212) to be reimbursed by the United States Environmental Protection Agency (USEPA) through a grant from the Great Lakes Restoration Initiative Grant Number (FAIN) GL-00E01926-0 for the Bull Creek Restoration Project in Beach Park, Illinois.

Permits and Enforcement

6.3 <u>16-0501</u>

Ordinance amending Chapter 94: Public Nuisances, of the Lake County Code of Ordinances to expand available pre-violation notice options for enforcement staff.

Matt Meyers presented the proposed amendments to the Public Nuisance ordinance.

The ordinance change will allow more flexibility in the "warning" phase of the administrative adjudication ticketing process to allow for a pre-warning letter in lieu of a site visit. The amendment will also allow staff to skip the warning process for chronic nuisance violators. The Committee asked staff for an update once the new procedure was implemented and once enough cases were handled under the procedure to draw conclusions about efficacy. Staff also discussed the potential for ongoing periodic reporting of compliance trends.
