Susan Knight, Health Department, noted that this donation will help purchase "Adapt Naloxone Kits" for police departments and other first responder units.

Member Calabresa provided a brief background on how the Jordan Michael Filler Foundation was organized.

Member Mandel asked if the cost of the Naloxone kits are increasing. Member Calabresa reported that the only Naloxne kits that are increasing in price are the kits that are administered by an epinephrine syringe.

#### 7.3 16-0832

Joint resolution accepting the Illinois Department of Commerce and Economic Opportunity (DCEO) Workforce Investment Act (WIA) Local Incentive grant, Trade Adjustment Assistance (TAA) grant modification and WIA Rapid Response grant modification and authorizing an emergency appropriation in the amount of \$325,104.22.

Jennifer Serino, Workforce Development, reported that due to exceeding performance measures from the Workforce Development programs the Workforce Investment Act (WIA), Local Incentive, granted \$15,085 to Lake County. This grant will be used for activities, and services allowable under the WIA. In addition, there are grant modifications

from Trade Adjustment Assistance (TAA) and WIA Rapid Response for tuition costs for dislocated workers' training programs and, overhead costs.

Member Hart asked where the trainings will take place. Ms. Serino noted that some programs take place at the College of Lake County.

Member Calabresa commended the Workforce Development staff on their work efforts.

# 7.4 16-0941

Presentation by the Lake County Coalition for the Homeless regarding an overview of the organization's purpose and activities.

Jodi Gingiss, Community Development, introduced James Menzer, Homeless Education Coordinator, of the Regional Office of Education. This presentation had been previously announced to the committee.

Mr. Menzer reported that the Lake County Coalition for the Homeless (LCCH) helps homeless children attend school by using different forms of public transportation. Statistics were provided on the number of homeless students in several school districts and it was clarified that the numbers only include children that attend school.

The LCCH is a group of individuals and community organizations that do their best to ensure that the homeless have access to services and housing. The LCCH is funded by the U.S. Department of Housing and Urban Development (HUD) and by donations.

It was reported that there are four different types of homelessness including couch surfing or doubled up, meaning living with friends or family. The second type of homelessness would include living in shelters, or living in a place, that is not meant from habitation. The other two types of homelessness include being chronically homeless, and individuals at imminent risk.

Two leading factors of becoming homeless are lack of money and domestic violence. Data was provided on the amount of homeless people that are sheltered versus unsheltered, living with sever mental illness, chronic substance abuse, victims of domestic violence and individuals living with HIV/AIDS.

The LCCH plans to implement their mission of eliminating homelessness by identifying community needs and exploring ways to fill gaps in services. The LCCH will utilize Service Point to share information and increase opportunities to collaborate and reduce

duplication of services.

Member Pederson indicated that it would be a good idea for all of the members of the Health and Community Services Committee to volunteer for the annual point-in-time count of sheltered and unsheltered homeless people in Lake County.

There was general agreement that as many committee members are possible would participate in the point-in-time count. As the event gets closer, Assistant Administrater davis will notify the committee members of the appreciate information.

#### 9. County Administrator's Report

# 9.1 16-0922

Presentation and discussion regarding the fiscal year (FY) 2017 Legislative Program Proposals.

Adlil Issakoo and Ben Gilbertson, of the County Administrator's Office, presented on the fiscal year (FY) 2017 legislative program proposals. Mr. Issakoo noted some of these items were on last year's proposal. Department Heads were sent a questionnaire asking for proposal items that need some legislative attention or that need County sponsorship or support. Items include changes to the Health Insurance Portability Accountability Act (HIPAA) Law which is under the federal support initiative and is tied into the Michael Phillip Filler Foundation. The County is working with the National Association of Counties Organization (NACO) to make changes to the HIPAA law.

Mr. Gilbertson reported on the State initiative to support any legislation to reduce opioid addiction. The County monitors different types of initiatives that are passed and Mr. Gilbertson noted that this is a broad support category. Member Calabresa spoke in regards to House Bill 1 that was passed a year ago and noted that she would like to see

attention go towards the monitoring of prescription drugs. Mr. Issakoo noted that the County Administration's Office will look into this.

Chair Carlson requested information on the Judicial Facility fee. Mr. Issakoo noted that the County is looking for permissive authority to set a fee of \$30. Mr. Gilbertson added that the fee, would generate approximately \$4,700,000. If the fee was instituted at \$15, it would generate approximatly \$2,400,000.

Discussion ensued regarding the State fees and other proposed programs.
