Tobacco 21

On June 12, the Village of Lincolnshire voted in favor of increasing the minimum legal sales age (MLSA) of tobacco products to 21. This ordinance took effect immediately.

On July 5, the Village of Vernon Hills also passed an ordinance to increase the MLSA for tobacco products to 21. This ordinance will go into effect August 1, 2017.

So far, nine communities in Illinois have passed tobacco 21 ordinances: Evanston, Chicago, Oak Park, Naperville, Deerfield, Highland Park, Maywood, Lincolnshire, and Vernon Hills.

The Tobacco Free Lake County program at the Lake County Health Department is educating municipalities and soon, unincorporated residents in Lake County on the benefits of increasing the MLSA.

Current communities considering Tobacco 21 ordinances include Buffalo Grove, North Chicago, and Mundelein.

A Tobacco 21 ordinance for unincorporated Lake County will be discussed at a public hearing on July 21, 10:00 AM, at the Lake County Central Permit Facility, 500 W. Winchester Road, 2nd Floor Conference Room, Libertyville, for the purpose of receiving public comment on proposed revisions to Lake County Code of Ordinance Chapter 177: Tobacco Regulations.

In 2015, the Institute of Medicine released a report highlighting the benefits of increasing the MLSA for tobacco products. Some of those benefits include:

4.2 million years of lives saved in children alive today

25% drop in youth initiation

12% drop in overall smoking rates

12% drop in premature births

16% drop in SIDS

"Fight the Bite" to protect yourself and your family from West Nile virus

With warmer weather come more mosquitoes. The health department reminds residents to take precautions to protect against West Nile virus, an illness spread by mosquitoes.

Since 2002, there have been 58 confirmed cases of West Nile virus in Lake County, as well as two confirmed deaths.

To help prevent mosquitoes from breeding around your home and business and protect yourself from bites, follow the "4 Ds of Defense":

Drain: Drain standing water from items around your home, yard, and business.

Defend: Use an insect repellent containing DEET when outdoors.

Dawn to Dusk: Protect yourself all day and night, and be especially aware during the prime times for mosquito activity, dawn and dusk.

Dress: Wear long sleeves, pants, and closed toe shoes when outdoors to cover skin.

Residents can contact the West Nile virus hotline at (847) 377-8300 to report areas of stagnant water, report locations of dead birds, and obtain more information on West Nile virus.

The Focus was on the Talent Economy at Lake County Partners' Recent "Big Event"

Over 500 tickets were sold for Lake County Partners' recent "Big Event"—the organization's signature forum which brings together Lake County's business and civic leaders to strengthen and leverage the region's economy. The event continues to grow each year, and is supported by a wide variety of businesses and organizations, including Lake County.

This year's focus was on growing the talent economy. Lake County has the strongest workforce in the region, and the efforts of the Workforce Ecosystem partners (Lake County Workforce Development Department, the College of Lake County, Lake County Partners and others), are ensuring that business needs are aligned with a strong pipeline of highly-skilled talent.

At the event, Lake County Partners unveiled a new video and a new annual report which showcase how growing companies are benefiting from local programs and initiatives. Personal stories from Sysmex America, the Lake County High Schools Technology Campus, R&D Automation, Horizon Pharma, Flexan, MacLean-Fogg, Highland Park Hospital, the Village of Libertyville and Mesirow Financial illustrated the powerful impact that the Workforce Ecosystem is having on both employers and employees in Lake County.

Lake County Board Chairman Aaron Lawlor provided a leadership update for the crowd, in which he welcomed Lake County's 12th Fortune 500 company, Caterpillar, which will be moving its headquarters to Deerfield later this year.
