CHAIRMAN'S REMARKS

Carol Calabresa – August 14 Lake County Board Meeting

As Vice-Chair of the County Board, I am serving as acting chair during Chairman Lawlor's leave of absence, per our Board Rules.

As many of you have read in the media, Chairman Lawlor is on a leave of absence for

treatment for drug addiction at the Hazelden-Betty Ford Foundation.

Addiction is a chronic, relapsing brain disease—a recorded disorder treated with a combination of medicine, counseling and family support, just like cancer, diabetes or heart disease.

This Board has consistently demonstrated its leadership in the areas of addiction and mental/behavioral health. We are the only local government in the region to dedicate 100% of Video Gaming Revenue for addiction and mental health services. This illustrates our commitment to support all Lake County residents experiencing this chronic disease. In one of my first actions as Acting-Chair, I directed staff to review our policies and procedures regarding P-card transactions and report the findings and any recommendations to the County Board by the end of September. The State's Attorney released in a statement that an independent, third-party organization is conducting a complete investigation. Based on OUR attorney's advice, we should not discuss these details as not to compromise the investigation.

I'm confident that during this time, this Board will continue to work together with professionalism and respect and deliver on our mission to serve the public and provide exceptional services.

Zion Health Center Public Open House

On Friday, August 17, the Health Department will host an open house event at the new Zion Health Center, located at 1911 27th Street, Zion. The event will take place from 3:00-7:00 p.m. The family friendly event will include tours of the newly renovated facility, activities for children, light refreshments, giveaways, information on Health Department programs and services, and the opportunity to schedule appointments including school physicals and immunizations. West Nile virus on the rise in Lake County

The Health Department monitors and tests mosquito populations for West Nile virus, in coordination with Clarke (a mosquito control company) and the Lake County Forest Preserve District. As of July 27, 18 mosquito pools (or batches) and two birds have tested positive for West Nile virus in Lake County, tracking ahead of the seasonal average in Lake County. The population of nuisance mosquito species has also been higher than average. There have been no confirmed human West Nile virus cases in Lake County. However, summer and fall are prime times for West Nile virus depending on the weather.

Most people infected with West Nile virus have no symptoms of illness. However, some may become ill usually three to 15 days after the bite of an infected mosquito. If you start to feel achy, nauseated, have a fever, swollen lymph glands or a rash after being bitten by a mosquito, see your primary care provider. Cyclospora food-borne illness outbreak

Since May, the Health Department has investigated 43 cases of Cyclospora infection among Lake County residents. This is more than 14 times higher than the number of cases reported in 2017. Cyclospora infection may occur when a person consumes food or water contaminated with the Cyclospora parasite. Symptoms typically begin one to two weeks after exposure and can be treated with specific antibiotics. If left untreated, symptoms can last weeks to months. Common symptoms of Cyclospora infection include watery diarrhea, stomach cramps, nausea, vomiting, fatigue, loss of appetite, weight loss, muscle aches, and low-grade fever. Those experiencing symptoms are encouraged to seek testing from a health care provider. More information is available on the Health Department website.

The Lake County Health Department's Animal Care and Control will hold a low-cost pet vaccination and microchip clinic on September 8, 9 a.m. to noon at the Village of Grayslake Building, located at 10 South Seymour Avenue, Grayslake. The clinic is open to all Lake County residents. Pets are taken on a first-come, first-served basis. Only cash is accepted at the time of service. All animals must be at least 4 months old. Dogs must be leashed and cats placed in carriers. Rx for Health: Walking in Nature

The 2018 Rx for Health: Walking in Nature season continues. The simple act of walking, especially in nature, can improve one's overall health, both physically and mentally. The next two walks are scheduled for: Saturday, August 25 at McDonald Woods (19611 W. Grass Lake Road, Lindenhurst). Meet in the parking lot off Grass Lake Road. Saturday, September 15 at Captain Daniel Wright Woods (24830 St. Mary's Road, Mettawa). Meet in the main parking lot off St. Mary's Road. All walks are from 4:00-5:30 p.m. and range in length from 1 to 2 miles. Everyone can walk at their own pace and distance. Walks are guided by a NorthShore physician, a Lake County Forest Preserve naturalist, and staff from the Lake County Health Department and Community Health Center. The walks are open to all ages, but those 16 and younger must be accompanied by an adult. These are rain or shine events. With the exception of service animals, pets are not allowed. August is National Immunization Awareness Month

Vaccines are a safe and effective way to prevent serious and sometimes deadly diseases.
