 Discuss Lake County Government Reform and Accountability Commission recommendation to develop a process for establishing an Independent Advisory Redistricting Commission.

Chair Lawlor spoke about the current redistricting process and district boundaries.

Kathy Ryg, Vice-Chairman LCCGRA, gave committee an overview and background on the Illinois Independent Maps Initiative. Handout of the Illinois Redistricting Collaborative Redistricting Reform Principals was discussed. Kathy noted that the Redistricting Reform will offer diverse voices and independent thinkers an opportunity to serve. She noted that the public must be allowed to participate in the planning process and educate them so that they better understand the process. Kathy reported on the eight criteria that will help guide consideration in Illinois map-making. Lake County's goal is to build on how we can maximize these opportunities and make it more transparent.

Kevin Knutson, Management Partners, presented his recommendation on the independent redistricting process. At the May 1st meeting, a draft of the Independent Redistricting report will be reviewed. On June 5th, the final draft will be presented again to discuss any potential issues prior to approval. Members agreed that the commission's role be approved by County Board.

Substantial discussion ensued.

Consensus to hold the June 5 meeting and June 26 meeting, all approved.
