Discussion on Lake County Redistricting Framework.

Kevin Knutson, Management Partners, reviewed drafted Redistricting Framework Plan and pointed out the recommended changes.

Members expressed minor changes to the document. Discussion ensued regarding membership, appointments and map redistricting. Members all agreed that County Board should establish the membership of the commission's leadership. Lake County Redistricting Framework Plan to be brought back to committee for final approval and recommendation to County Board for approval.

Members were reminded that outside counsel is hired to lead the redistricting mapping process. Draft of the Redistricting Framework Plan to be brought back to committee one more time for member approval. Chair Lawlor reemphasized the three priorities of the Reform Implementation Committee: 1. Independent redistricting (size of districts, number of districts); 2. clarifying the roles and responsibilities of the County Board Chair and County Board members; 3. Other recommendations in Commission's final report.

Members discussed Attachment A – List of Recommendations. Members agreed to remove Recommendation #12.

All members agreed that further discussion on Chair's roles and responsibilities take place prior to approving the final Redistricting Framework Plan.

8.2 <u>18-0758</u>

Discussion on Lake County Government Reform Implementation Committee Priorities and Next Steps.

- The Lake County Government Reform and Accountability Commission (LCGRAC) was created by the County Board in 2017 to explore reform measures, including redistricting, the method of electing the chair, and the size of the county board.
- The LCGRAC issued its final report in December 2017 with 12 recommendations and concluded that Lake County functions well and has the opportunity to be a leader in pursuing independent redistricting.
- The Government Reform Implementation Committee approved a 2018 Work Plan that
 included the following areas in this priority order: (1) Independent redistricting (2) Clarify the
 roles and responsibilities of County Board Chair and County Board members (3)
 Review/discuss other recommendations in Commission's final report.
