#### 5.1 18-1543

PY2019 Public Services and Video Gaming Revenue Applications - Review, Discussion and Recommendations

Presented by Jodi Gingiss, Community Development Administrator, and Eric Foote, Grant Administration Specialist

Ben Richards, of the Waukegan Park District, spoke about the Park District's before and after school program, which provides affordable and reliable childcare, enabling low-income parents to work. Funding was requested to expand the program to accommodate additional children.

Reverend Jackie Lynn, of ElderCARE, informed the ARC about the continued increase in transportation services provided to Lake County's seniors by the agency's volunteer drivers. She added that a recent client survey showed that 30% indicated having ElderCARE's services available reduced their stress levels.

Diana Helt, of Great Lakes Adaptive Sports Association (GLASA), thanked the ARC and the HCDC for the continued support of GLASA's programs, as well as having a Consolidated Plan (Plan) goal to assist people with disabilities. She asked that this goal continue into the new 5-year Plan, as it positively effects people with disabilities, and the HCDC's support has allowed GLASA to grow significantly.

A discussion was held about increasing the staff recommended funding amount to Zacharias Center to the agency's requested amount of \$5,000, an increase of \$2,500. David McDermott, of the Lake County Health Department, was asked if the Health Department's Community Supportive Services program would be able to absorb a decrease in proposed funding by \$2,500. He offered that he believed the reduction would not adversely affect the program.

Motion: To alter staff's Video Gaming Revenue funding recommendations by reducing the Lake County Health Department's suggested award to \$82,500 and increasing Zacharias Centers suggested award to \$5,000.
