#### 7.2 19-0045

State Legislative Session Discussion. (30 minutes)

Kent Gaffney, McGuire Woods Representative present via phone, provided a general overview of the legislative process, anticipated items in the upcoming session and how it may impact legislation of interest to the County. Member Didech inquired about whether the County has a predeveloped list of assets for inclusion in a capital bill. Chair Wasik inquired about how to more effectively connect with legislators. Member Martini noted in previous years the Ad Hoc Legislative Committee implemented a legislative breakfast to meet and discuss items of interest with legislators. She recommended considering it this year as it was very helpful in the past. Chair Wasik stated that staff have been working with the legislators to implement a breakfast for this legislative session. Discussion ensued.

## 7.3 19-0046

Overview of Fiscal Year 2019 Lake County Legislative Agenda. (45 minutes)

Assistant County Administrator Paul Fetherston provided an overview of the Legislative Committee (Committee) agenda, steps to amending the agenda, guiding tenets, schedule, and initiatives received for consideration.

Vice-Chair Martini inquired about legislation to reduce property taxes and recommends including it in the legislative agenda for support or sponsor. Chair Wasik noted his endorsement and would like to seek a comprehensive solution to alleviating property taxes. Member Didech inquired about how this modification would affect staff and McGuire Woods Representatives. Discussion ensued. There was a Committee consensus to have staff draft an amendment to the legislative agenda supporting and/ or sponsoring property assessment and tax reform legislation.

Mr. Fetherston noted staff is in the process of developing a legislative priorities survey for all County Board members.

# 7.4 <u>19-0044</u>

Request to amend FY 2019 Lake County Legislative Agenda to include an item to sponsor legislation enabling the removal of a County Board Chair.

Mr. Fetherston explained Senate Bill 1485 providing that a chairman of a county board who is chosen by the board may be removed, with or without cause, upon a motion adopted by an affirmative vote of four-fifths of the board and that upon adoption of a motion to remove the chairman: (a) the chairman position becomes vacant and the former chairman's compensation shall be prorated to the date the motion was approved; (b) the vice-chairman immediately assumes the duties of chairman without chairman compensation; and (c) a new chairman shall be elected at the next regularly scheduled county board meeting. A chairman removed under this Section maintains his or her status as a member of the county board.

Mr. Fetherston sought direction from the Committee regarding amending the legislative agenda to include the sponsorship of a similar bill in the upcoming session. Member Didech inquired about the state statutory authority being sought in the event of a resignation. Member Rummel inquired about whether it is incumbent on the County Board to elect a County Board Chair of the same political affiliation as the former chair in the event of a resignation. Discussion ensued. Amy McEwan, Interim County Administrator, provided clarification regarding the language of the legislation indicating the span of time over which a chair is unable to satisfactory maintain their duties before the position is considered a vacancy. Member Simpson inquired about creating separate language specific to the removal of a chair. County Board Chair Hart expressed that the language should focus on the removal of a chair and should there be a vacancy the County Board needs to have the authority to select another chair. Vice-Chair Martini noted her support for this legislation and inquired about the residency requirement to become a County Board member or County Board Chair. Discussion ensued.

A motion was made by Member Didech, seconded by Member Simpson, amending the FY 2019 Lake County Legislative Agenda to include an item to sponsor legislation enabling the removal of a County Board Chair. Motion carried by voice vote.
