7. President's Report

President Sashko reported on the following:

1. Work on the Ethylene Oxide concerns in Waukegan and Gurnee continues and the Board has been kept abreast of it. Air sampling options and the shared costs with both

communities is being looked in to. Mark Pfister recently sent a correspondence petitioning the National Center for Environmental Health/Agency for Toxic Substances and Disease Registry (ATSDR) to perform a health risk assessment based on the EtO air sampling that will be done.

- 2. T-21 was sent to the Governor's desk and hopefully he will sign it into law prior to any other legislation like HB3178. There is other pending legislation that would separate e-cigarettes from the equation and that is being worked on to oppose.
- 3. April 12, 2019 is the annual employee appreciation breakfast. It is at Thunderhawk Golf Course in Beach Park. Attendees should arrive around 8:00–8:15 as it starts at 8:45. RSVP to Lisa Kroeger.
- 4. The 2017 report from the Illinois Primary Health Care Association (IPHCA) was recently received. This report relates to the Health Department's FQHC operations as far as the impact it has on the overall efficacy within the county. This evaluation is conducted every three years. Assists in obtaining community foundation/grant funding. When the indirect impact to operations is added, we are over 80% higher in economic output versus direct alone for the state of Illinois. Some of the amazing, and not always appreciated, values are:
- a. Health Department FQHC operations generated more than \$32.2 million through the provision of medical care to the community in 2017. That is salaries, additional jobs and the support of industry services that resulted in an overall economic contribution of \$54.4 million to the local workforce and economy.
- b. Labor income for the FQHC was \$27.8 million through combined direct and indirect employment of 338 full-time equivalent jobs in the county. The Health Department, overall, is the single largest Lake County governmental employer.
- c. That directly relates to an indirectly generated 130 additional full-time jobs through the use of goods and services making the overall impact 468 ful-time equivalent jobs.
- d. Economic approach simplified, there is a "multiplier effect" that determines the total consequences of our activity in the local economy, Output Multiplier, Earnings Multiplier and Employment Multiplier. The Health Department supports the economy and other businesses support the Health Department in it's operations.
