State's Attorney presentation on Liquor Commission Ordinance and Application changes.

Jamie Helton, State's Attorney's Office, gave a presentation regarding the changes for the liquor application and ordinances. The changes to the application will be the criminal background questions and to make the application clear and precise. For the ordinance, the verbiage for the waiver provision will be changed to also be clearer and more precise. The application will then be accessible on-line.

Continuance on Hearing for Donny's Diner.

Christopher Pierce, Attorney, representing Donny's Diner, stated the owners of the property still have landscaping to be completed in order for the leaser to receive their liquor license. The property is currently red tagged. The signatures from Planning, Building and Development is needed prior to receiving a liquor license.
