Matt Meyers, Assistant County Administrator, presented agenda item 7.3. Mr. Meyers led a discussion regarding active legislation/bills of interest.

RuthAnne Hall, Purchasing Manager, discussed the details of Senate Bill 2305. Mr. Meyers stated the initial recommendation would be to oppose this bill. Discussion ensued and the committee came to a consensus to oppose this bill as written.

Senate Bill 2322 was presented and discussion ensued. The committee came to a consensus to oppose this bill.

Mr. Meyers informed the committee that we will not move any further on Senate Bill 2341.

Mr. Meyers presented House Bill 4135 and informed the committee that there will be a hearing on February 5, 2020 at 10:00 a.m. regarding this bill. Derek Blaida, Lobbyist, discussed the status of the bill and the committee came to a consensus to oppose.

Mr. Meyers presented House Bill 3624/Sentate Bill 2132 and informed the committee that the Energy and Environment Committee gave direction to support this bill. Hannah Mulroy, Interim Sustainability Coordinator, gave a brief statement regarding the bill. Ms. Mulroy discussed that the bill would help move Illinois toward 100% renewable energy by 2050, implement smart electric vehicle policies, improve energy efficiency programs, and promote the development of renewable energy. Ms. Mulroy stated that she feels this would allow Lake County to pursue their own renewable energy and energy efficiency bills. Substantial discussion ensued. The committee came to a consensus to support this bill.

Walter Willis, SWALCO Executive Director, discussed the details of the Drug and Sharps Waste Stewardship Bill. Substantial discussion ensued. The committee came to a consensus to support the bill.

Mr. Meyers discussed the creation of the Illinois Route 53 Expansion and Alternative Use Task Force. Discussion ensued.

This matter was discussed.

9. County Administrator's Report

Matt Meyers, Assistant County Administrator, introduced Arin Thrower, Lake County's new Chief Communications Officer. Mr. Meyers also reminded the committee about the Joint Legislative Breakfast on February 8, 2020.
