Member Simpson questioned the need for the work associated with item 22, the widening and reconstruction of Buffalo Grove Road between Deerfield Parkway and Illinois Route 22. Shane Schneider, Division of Transportation Director, reported that the road is at the end of its life, noting that the road was last reconstructed in the 1980s.*

*Legislative Committee - Member Wasik reviewed item 25, regarding Fiscal Year 2020 Legislative Agenda. Adam Berger, Petland owner, expressed opposition to the legislation regarding pet shop dog/cat sourcing. He indicated that this legislation will solely impact his business. He expressed opposition to the proposed legislation and invited members to tour his breeder's facility. Matt Schucker, Alyssa Goroski, and Jessica Appicelli, Petland employees, also expressed opposition to the proposed legislation. Denise Rolando, Annette O'Connell, and Karen Sandy, Go Humane Lake County, expressed support for the proposed legislation. Sharon Langlotz-Johnson, reported that State Representative Tom Weber would not be in favor of supporting any legislation that would hamper economical development of small businesses in Lake County. Sara Stewart, Ruff Luck Dog Rescue, expressed support for the legislation and the need to improve standards regarding responsible pet ownership. Member Maine indicated that the language in the legislative agenda needs to be better defined and clarified. Substantial discussion ensued.*
