Member Barr moved to amend the language to grant an extension to April 8, 2020 so that a Special Call meeting can be held. Parliamentarian Matt Norton reported that Special Call meetings cannot be done via a motion. He reviewed the procedures to hold a Special Meeting on April 8, 2020. Discussion ensued. Motion withdrawn.
