Eric Foote, of PADS Lake County, stated through the Chat Box his thanks to the Commission "for assembling and dedicating time to this process. PADS continues daily to provide shelter in hotels to people in Lake County who fall into homelessness. The

future is very uncertain. We're spending about \$100,000 in hotels each month and are unsure how far into the future we'll need to keep this going or whether our expenses will increase as a result of the economy, the virus and the willingness of our volunteer corps to return to church-basement sheltering situations. These funds will go a long way to ensuring shelter for individuals well into 2021, which will provide a helpful and safe option for people and ensure a strong safety net for Lake County residents during the pandemic and beyond. I am happy to answer any questions you have about PADS and our current operations and our projections for the future. And thank you again for your service."

If all proceeds smoothly, staff anticipates ESG-CV2 contracts being sent to providers in December or January. She added that \$2,000,000 of State ESG-CV2 funds will be distributed through the Homeless Coalition. Lake County's HUD contracts were just signed by Chairman Hart and she reminded the members that a new application round will begin shortly for PY2021 funds.
