Operations Chair Pat Kreis reported that as the RFP process continues, there is a need to maintain the current consultant's (Crowe) services moving into the next phase of the process. Consortium funding remains to cover the expense, if it is the desire of the committee.

Both the Operations and Policy Committees provided guidance and consensus to have the project manager, Jim Hawkins, move forward with retaining Crowe for the next phase of the project (Task 4 - Negotiation.)

Additional discussion ensued regarding extending the Intergovernmental Agreement and considering a dedicated project manager moving forward.

Future actions and agreement supporting the approved Regional 911 Consortium Concept of Operations and Implementation Plan was discussed.
