Discussion of opportunity to preserve affordable housing units and boost spending of Community Development Block Grant (CDBG) and HOME Funding.

Presented by Brenda O'Connell, Community Development Administrator.

Brenda provided an overview of the current need for expedited spending of Community Development Block Grant funds. Over three million dollars needs to be spent prior to the end of February in order to pass HUD's timeliness test. In order to accelerate funding, staff will continue to work with current grantees to quickly spend funding. Staff will assess the viability of Tier 2 projects to quickly spend. Finally, Brenda proposed a special application round to preserve affordable housing units that the Lake County Housing Authority is working to sell. She advised that a special round of applications would be the best opportunity to spend the funds in a manner that also effectively addresses the County's Consolidated Plan goals. Discussion ensued. Chair Rose asked the commission to allow Brenda and the Community Development staff to pursue a special application round. Brenda will present details for commission approval at the next Housing and Community Development meeting in July 2021.
