Mark Pfister informed the Board that various changes to the bylaws have been reviewed and approved by Board legal counsel Lisle Stalter. The changes on page 6 and 7 are to allow members to attend meetings and vote through video means if there is due cause based on the reasons noted, but in order for that to happen there must be a physical quorum present in the Board Room. The changes on page 4 would move the business of the Board to a consent agenda which is what the County Board uses. The benefit of a consent agenda is that action on all routine non-controversial business items (i.e., minutes, committee appointments, etc.) can be taken through one motion, one second, and one vote. ## 11. Lake County Community Health Center Governing Council Update

Mark Pfister informed the Board that HMA, the management consultant, has met with management staff and are providing recommendations on how we can improve and prepare for moving forward with value-based care thinking and concepts. Ensuring the management team has a good understanding of value-based care is a critical first step in this process. HMA is also going to be making recommendations on job descriptions and roles, and ensuring we have standardization across all of our FQHC sites. The complete results will be brought to the Governing Council for their review as they are in charge of FQHC operations. The entire process has been a very positive experience for staff as well as leadership.

#### 14. Old Business

Mark Pfister provided the following updates:

Adenovirus: The working hypothesis is that adenovirus type 41 is the possible cause of the recent children's hepatitis cases of which there are none in Lake County. As of May 18, 2022, in the United States there have been 180 persons from 36 jurisdictions under investigation. The racial and ethnic breakdown is unknown. Greater than 90% have been hospitalized, 8% have required a liver transplant, 5 deaths have been investigated, and greater than 50% have been confirmed as related to the adenovirus. The infection is with and without co-factors such as lack of exposure to others during the COVID-19 pandemic, co-infection with another pathogen such as COVID-19 or SARS-COV-2, prior exposure to SARS-COV-2, long COVID, toxins, drugs, or other environmental exposures. This may be a new pathogen. The evidence is that this virus is not a well recognized cause of hepatitis in healthy children, the pathology is not consistent with typical adenovirus hepatitis in immunocompromised children. And the evidence of viral infection is not yet being detected in the liver. There are still a lot of unknowns but it is relatively rare in the United States. At the international level, as of May 13 in the euro-region, there was 232 cases reported from 14 countries.

COVID-19: In Lake County, there are 314 cases per day on a 7-day rolling average which is down from last week's 340 cases. We are starting to see a plateau in reported cases, but we know they are under-reported because people are testing at home and not reporting positive cases. Hospitalizations have seen a slight uptick and the majority of those being hospitalized are unvaccinated. Deaths are down as there has been only six since May 1, 2022. Member Simpson asked about the current vaccination rate in 5 to 11 year olds. Mark stated that this has been a disappointing age group as Lake County has been sitting at 47-48% for two months. While parents may be feeling that the virus isn't going to be harmful to their children, our statement is, "Why take the risk?" The vaccines have been shown to be very low risk and if your child does get COVID-19, why risk being the one to be hospitalized and potentially die. For those age 65 and above, more than 98% have at least one dose and close to 90% have two doses. Now that boosters are available we expect to see more people getting them. And for those fully vaccinated and boosted, the risk of hospitalization and death is extremely low. The omicron variant currently circulating is BA.2 and it is very infectious. Lake County may move to "high" community level on Friday, May 27, due to the number of hospitalizations and not the number of cases. If that happens, we will be strongly recommending that people mask in public places.

Monkey Pox: It is not transmitted through the air like COVID-19 (droplets required) and, at this point, it is mainly in populations where men are sleeping with men. The cases in the United States are linked to individuals that traveled abroad. And it's been reported that a number of individuals connected to two raves that took place in Europe is where the monkey pox is potentially emanating from.
