8.2 22-1087

Update and discussion on the State of Illinois 2022 Legislative Sessions.

Derek Blaida and Mike Grady of Strategic Advocacy Group gave a brief summary of the 2022 state legislative session.

Mr. Blaida noted that the spring legislative session adjourned on April 8, 2022 and that the fall veto session is scheduled to begin on or around Tuesday, November 15, 2022. Mr. Blaida added that there may be a special session scheduled to discuss solutions in response to the mass shooting in Highland Park. However, as of today, no such session has been scheduled. Mr. Blaida also noted that State Representative Bob Morgan was

appointed the lead of the Firearm Safety and Reforms Working Group, as established by the Speaker of the House. Mr. Blaida further noted that State Representative Morgan will reach out to gather input and suggestions.

Mr. Grady also noted that for any session that occurs prior to January, any legislation with an immediate effective date will require a super majority to pass. Mr. Grady added that a final lame duck session will take place in January.

Discussion ensued.

8.3 <u>22-1088</u>

Discussion regarding possible amendments to the 2022 Legislative Agenda related to firearm regulations.

Public comment was given in-person by Jennifer Muccianti and Travis Haley.

Member Frank proposed that the Committee consider a County policy change that would add to the County's Legislative Agenda support of: banning the sale of assault rifles, firearm safe storage law, and amendments to the FOID process.

Discussion ensued.

Matt Meyers, Assistant County Administrator, clarified that today's discussion is for committee consensus, not for formal committee action.

A motion was made by Member Frank, seconded by Vice Chair Casbon, to amend the 2022 Legislative Agenda and to include in the 2023 Legislative Agenda, the firearms regulation language put forth by Member Frank.

Discussion ensued.

Assistant County Administrator Meyers summarized the request from the Committee. He stated the amendments would move forward, bypassing a formal Committee action, per the County Board rules, with approval from the Committee Chair and the Board Chair. It would then be placed on next week's County Board agenda. Chair Wasik voiced his approval and requested a roll call to verify committee consensus.

Legislative Committee

Discussion regarding Lake County's Fiscal Year 2023 Legislative Agenda.

Matt Meyers, Assistant County Administrator, noted that communication was sent out to all County-wide elected officials and department heads regarding ideas to add to Lake County's 2023 Legislative Agenda. Assistant County Administrator Meyers noted that Robin Grooms, Sustainability Programs Manager, and Walter Willis, Director of SWALCO, have been invited to speak about their ideas at the next Legislative Committee meeting. Assistant County Administrator Meyers then invited Eric Waggoner, Planning, Building and Development (PB&D) Director, to give a summary of his idea for the 2023 Legislative Agenda.

Director Waggoner explained that, in order to move forward with certain sustainability policy initiatives related to the development and use of County land, some changes need to be made through state law to allow the County to create and enforce sustainability zoning regulations. He noted that staff is proposing clarification of the County Zoning Enabling Act to explicitly provide for the mitigation of environmental hazards through zoning authority; thus allowing the County to adopt requirements for a number of sustainability-related issues.

Discussion ensued.

The consensus of the Committee was to support the proposed amendment to the County Zoning Enabling Act. Assistant County Administrator Meyers noted that he will work with Director Waggoner to draft specific language to include in the draft 2023 Legislative Agenda.

Assistant County Administrator Meyers noted that he will circle back on requests from other department heads and County-wide elected officials with the goal of presenting the draft 2023 Legislative Agenda for the Committee to vote on in October.

9. County Administrator's Report

There was no County Administrator's Report.

10. Executive Session

The Committee did not enter into Executive Session.

11. Members' Remarks

Vice Chair Casbon gave a brief update on the Honoring our PACT Act of 2022.

Chair Wasik thanked Vice Chair Casbon for the update and for initially bringing attention to the issue of veterans' exposure to burn pits.

Chair Wasik declared the meeting adjourned at 2:19 p.m.
