Dr. Mary Roberson with Northern Illinois Recovery Community Organization

"Good afternoon everyone. It's an honor and a pleasure to be here. I'm Dr. Mary Roberson from NIRCO, a not-for-profit located in Waukegan. We've been in existence for two and half years. We are located at the JIC Community Development Corp at 202 South Genesee Street. If you're familiar with that area, you know that the JIC building is a three level facility and we have the second level but we're also interested in doing some work on the third level. Initially we proposed a bathroom project, and as indicated, there has been a lot of difficulty in getting contractors. We have to get three approved, and for the amount of funding that we had, it's been very difficult to do that. So we would like to change the scope of the work to do a flooring project which has less contractors that's involved and with the flooring project we'll be able to expand our office spaces, our training spaces, and have more access for the community that is in need of the services over at NIRCO. I wanted to take this time, in advance, to thank you for the consideration of that project because it will be very vital to our community. Thank you so much for allowing me this time."

- HUD requires the submission of an Annual Action Plan (AAP) and associated amendments to govern expenditure of federal housing and community development funding for each program year.
- The Fifth amendment to the Program Year 2021 (PY21) AAP proposes Community Development Block Grant (CDBG) reallocations and a scope change to expedite project spending:
 - Reallocation of \$80,000 of CDBG funds from Thresholds to the City of Zion.
 - Reallocation of \$100,000 of CDBG funds from Community Youth Network to the Village of Round Lake Beach.
 - Scope change request from Northern Illinois Recovery Community

6.4 <u>22-0550</u>

Joint resolution approving an Intergovernmental Agreement (IGA) to administer American Rescue Plan Act (ARPA) funds awarded to the Lake County HOME Consortium.

- The American Rescue Plan Act (ARPA) appropriated \$5 billion of funding through the U.S. Department of Housing and Urban Development (HUD) HOME Investment Partnership Program (HOME-ARP) to address the need for homelessness assistance and supportive services.
- The Lake County Consortium consists of the County of Lake, the City of North Chicago, and the City of Waukegan.
- The Intergovernmental Agreement (IGA) sets the framework for the allocation and administration of \$6,025,377.00 of HOME-ARP funds awarded to the Lake County Consortium.
- Lake County, as the lead entity, is responsible for ensuring compliance with HUD HOME-ARP regulations.
- In accordance with County Board Rules, the State's Attorney's Office has reviewed this Intergovernmental Agreement.

The HOME- ARP Intergovernmental agreement is federal funding appropriated in the American Rescue Plan (ARP) awarded through HUD HOME Investments Partnerships Program (HOME) to Fiscal Year 21 (FY21) participating jurisdictions (PJs) through which the Lake County Consortium (Lake County, Waukegan, and North Chicago) received \$6,025,377. These funds must serve individuals or households who are homeless, at risk of homelessness, and other vulnerable populations.

HOME-ARP funds have four (4) eligible uses:

1. Production or Preservation of Affordable Housing

2. Tenant-Based Rental Assistance (TBRA)

- 3. Supportive Services, Homeless Prevention Services, and Housing Counseling
- 4. Purchase and Development of Non-Congregate Shelter

The HOME-ARP IGA sets the framework for the allocation and administration of HOME-ARP funds and allows a County-wide approach with no geographic set asides. Lake County serves as the lead entity thus responsible for HUD compliance and development of an allocation pan. Municipalities will have the opportunity to review the allocation plan prior to submission to HUD.

6.5 <u>22-0571</u>

Amendment to the Written Standards for Provision of Emergency Solutions Grants (ESG) Assistance for Landlord Incentives.

- The written standards for the provision of Emergency Solutions Grants have been developed to assure that ESG-funded programs are compliant and consistent across providers and contracts.
- Due to the impacts of COVID-19, HUD allows for ESG-CV funding to be used for landlord incentives valued up to three times the rent charged for the unit, including signing bonuses, security deposits, repairing damages incurred by the program participant not covered by the security deposit.
- Proposed standards were developed in collaboration with Lake County Coalition for the Homeless, serving as the Homeless Continuum of Care, to address barriers for homeless youth in accessing housing.
- Since the ESG-CV funding will end on September 30, 2022, Landlord Incentives will end at that time unless HUD provides additional flexibilities.
