That part of Asbury Avenue lying between lots 58 through 62 (both inclusive) on the west and lots 63 and 90 on the east and lying south of the south right of way line of Elm Tree Road and north of the north right of way line of Lotus Road, all in Asbury Terrace, being a subdivision of all that part of the north 867.24 feet of section 26, township 46 north, range 9, east of the third principal meridian, lying east of Grass Lake and that part of the northwest ¼ of the northwest ¼ of section 25, township 46 north, range 9, east of the third principal meridian, lying west of the center of Grass Lake Road, according to the plat thereof recorded May 7, 1931, as document 368220, in book "V" of plats, page 70, in Lake County, Illinois. The proposed area to be vacated is approximately 0.28 acres.
