Joint resolution approving an emergency appropriation to accept the Illinois Department of Commerce and Economic Opportunity (DCEO) Summer Youth Employment grant in the amount of \$359,142.

- The Illinois Department of Commerce and Economic Opportunity has provided a grant as part of the Statewide Summer Youth Employment Program to the Lake County Workforce Development Department in the amount of \$359,142.
- The grant is for the fiscal year June 1, 2010 to September 30, 2010, for a summer youth employment program.
- This funding is expected to provide summer employment for youth ages 16-24 at worksites throughout the county and will serve approximately 75 youth.
- An emergency appropriation of \$359,142 is requested to allocate these funds into the Workforce Department's budget and authorize acceptance of this grant.

**WHEREAS**, the Illinois Department of Commerce and Economic Opportunity has provided a grant as part of the Statewide Summer Youth Employment Program to the Lake County Workforce Development Department in the amount of \$359,142; and

**WHEREAS**, the grant is for the period of June 1, 2010 to September 30, 2010, for a summer youth employment program; and

**WHEREAS**, this funding is expected to provide summer employment for youth ages 16-24 at worksites throughout the County and will serve approximately 75 youth; and

**WHEREAS**, an emergency appropriation in the amount of \$359,142 is requested to be approved to allocate these funds into the Workforce Department's budget and authorize acceptance of this grant.
