- The County Board, at its meeting of December 13, 2011, approved the appropriation of \$30,000 of County Bridge Tax funds and \$30,000 of Matching Tax funds for FY 2012 miscellaneous maintenance materials and services.

RESOLUTION

WHEREAS, Lake County, by and through its Division of Transportation, maintains approximately 295 centerline miles of designated County highways on the County highway system; and

WHEREAS, Lake County, by and through its Division of Transportation, needs to acquire highway maintenance materials and services from time to time; and

WHEREAS, in order to acquire necessary maintenance materials and services, an appropriation of funds is required for each fiscal year; and

WHEREAS, this Lake County Board, at its meeting of December 13, 2011, approved the appropriation of \$30,000 County Bridge Tax funds and \$30,000 of Matching Tax funds for FY 2012 acquisition of materials and services needed to maintain drainage and bridge facilities, pavements, shoulders, guardrails, fencing, and right-of-way; and

WHEREAS, a supplemental appropriation of \$26,000 is required for acquisition of materials and services needed to maintain drainage and bridge facilities, pavements, shoulders, guardrails, fencing, and right-of-way.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that there is hereby appropriated a supplemental amount of \$26,000 County Bridge Tax funds for FY 2012 acquisition of materials and services needed to maintain drainage and bridge facilities, pavements, shoulders, guardrails, fencing, and right-of-way and designated as Section 12-00000-03-GM.
