- A request for qualifications was sent to 207 vendors with three firms submitting proposals.
- Staff from the Health Department, County Administrator's Office and Financial and Administrative Services recommend contracting with Health Management Associates in the estimated not to exceed amount of \$160,189.

**WHEREAS**, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, Request for Qualifications were called for by publication for the Public Health Programs Evaluation Consultant to perform a systematic review of programs and services provided by the Lake County Health Department and Community Health Center.

WHEREAS, subsequent to said publication, Request for Qualifications were extended to 207 vendors; and

**WHEREAS**, sealed proposals were received from three vendors and opened in the County Building, Waukegan, IL on February 17, 2012 at 2:00 p.m.; and

**WHEREAS,** based on the criteria set forth in the Request for Qualifications for Public Health Programs Evaluation Consultant, a panel consisting of staff from the Health Department, County Administrator's Office and Financial and Administrative Services recommend contracting with Health Management Associates.

**NOW THEREFORE,** be it resolved by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to finalize revisions as may be necessary and execute the agreement with Health Management
