Joint resolution approving an emergency appropriation to accept the American Reinvestment and Recovery Act (ARRA) grant and allocate the funds to Workforce Development.

- With the passage of the American Recovery and Reinvestment Act of 2009, the Illinois Department of Commerce and Economic Opportunity has awarded Lake County funds under the Workforce Investment Act.
- The total funds available for Lake County are \$5,202,612 and are available for expenditure from February 17, 2009 until June 30, 2011.
- Lake County Workforce will receive \$1,104,266 in Adult funds, \$1,657,089 in laid off worker funds, and \$2,441,257 in youth funds.
- Other changes as a result of this legislation are that the youth funds can be used for a stand alone Summer Employment Program and the age requirement for youth has been expanded to 24 years.
- Thus, an emergency appropriation needs to be approved to allocate these funds into the Workforce Department budget and authorize acceptance of this grant.

**WHEREAS**, with the passage of the American Recovery and Reinvestment Act of 2009, the Illinois Department of Commerce and Economic Opportunity has awarded Lake County funds under the Workforce Investment Act; and

**WHEREAS**, the total funds available for Lake County are \$5,202,612 and are available for expenditure from February 17, 2009 until June 30, 2011; and

**WHEREAS**, Lake County Workforce will receive \$1,104,266 in Adult funds, \$1,657,089 in laid off worker funds, and \$2,441,257 in youth funds; and

**WHEREAS**, as a result of this legislation the youth funds can be used for a stand alone Summer Employment Program for youth 14 to 24 years of age; and

**WHEREAS**, an emergency appropriation needs to be approved to allocate these funds into the Workforce Department budget and authorize acceptance of this grant.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$5,202,612 for the Workforce Development Department is hereby approved and that the Workforce Investment Act Grants be accepted. A chart of accounts will be provided to the Controller in a timely manner.
