Joint resolution authorizing the execution of Community Services Agreement # 11GM136000 with the Illinois Department of Human Services and an emergency appropriation of \$71,251 for the 19th Judicial Circuit of Lake County "Early Service Program (Delinquency Prevention)".

- This resolution authorizes the execution of Community Services Agreement # 11GM136000 with the Illinois Department of Human Services for the 19th Judicial Circuit's Early Service Program and an emergency appropriation in the amount of \$71,251.
- The agreement is for the period July 1, 2010 through June 30, 2011.
- Funding is used to procure contractual counseling services and related administrative costs. There is no required match.
- The Early Service Program has had 122 referrals during the current contract period.

WHEREAS, the 19th Judicial Circuit of Lake County Early Service Program (Delinquency Prevention) Agreement with the Illinois Department of Human Services (IDHS) expired June 30, 2010; and

WHEREAS, the IDHS has allocated funding for this program in the amount of \$71,251 for the time period July 1, 2010 through June 30, 2011; and

WHEREAS, these funds were not included in the county fiscal year 2010 budget, so it is therefore necessary to appropriate this funding and authorize the necessary approvals by the County of Lake to formally accept this grant.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that it hereby authorizes the execution of Community Services Agreement # 11GM136000 with the Illinois Department of Human Services and an emergency appropriation of \$71,251 for the 19th Judicial Circuit of Lake County "Early Service Program (Delinquency Prevention)" to be allocated as indicated on the attached chart of accounts; and
