Joint resolution accepting the Illinois Clean Diesel Grant funding from the Illinois Environmental Protection Agency in the maximum amount of \$70,216.

- Illinois Environmental Protection Agency Clean Diesel Grant: Acceptance
- Lake County has applied for and been awarded an allocation from the Illinois Environmental Protection Agency on behalf of Lake County Division of Transportation.
- This funding supports the County’s green initiative by retrofitting 16 vehicles with diesel oxidation catalysts and closed crankcase ventilation systems
- This funding provides for 100% reimbursement to the Division of Transportation for the cost of the retrofitting.
- The maximum funding available to Lake County through this grant is \$70,216.
- This grant is for fiscal year 2010 and is included in the Division of Transportation revenue and expense operating budget.

### RESOLUTION

**WHEREAS**, Lake County through its Division of Transportation has applied for funding and has been awarded up to \$70,216 in an Illinois Clean Diesel Grant from the Illinois Environmental Protection Agency; and

**WHEREAS**, Lake County, through it Division of Transportation, is entitled to 100% reimbursement of the cost to retrofit 16 vehicles with diesel oxidation catalysts and closed crankcase ventilation systems; and

**WHEREAS**, Lake County, at its board meeting of February 13, 2007, adopted a resolution

supporting Lake County's participation in the Green Illinois Government Campaign and the Illinois Green Government Coordinating Council; and

**WHEREAS**, Lake County, at its board meeting of April 14, 2009 adopted the Strategy for a Sustainable Lake County Plan; and

**WHEREAS**, the Division of Transportation has included the revenue and expense in its 2010 budget

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the acceptance and execution of the Illinois Clean Diesel Grant from the Illinois Environmental Protection Agency is hereby authorized.
