Joint resolution authorizing execution of a contract with National Power Rodding Corp., in the amount of \$1,660,023.56 for the 2013 Sanitary Sewer Rehabilitation Project.

- The County undertakes annual rehabilitation of deteriorated and aging sanitary sewer systems.
- The 2013 sewer rehabilitation project includes relining and spot repair to approximately 21,000 feet of sewers in the Northwest Sewer System.
- The County received bids from six contractors for this work, ranging from \$1,660,023.56 to \$2,332,310.
- Award of this contract is recommended to the lowest responsive, responsible bidder, National Power Rodding Corp., Chicago, IL in the amount of \$1,660,023.56.
- This resolution authorizes execution of a contract with National Power Rodding Corp. in the amount of \$1,660,023.56 for the Sanitary Sewer Rehabilitation 2013 Project.

RESOLUTION

WHEREAS, the County of Lake (County) owns, operates and maintains several sanitary sewer systems within the County; and

WHEREAS, these sanitary sewer systems are prone to deterioration and failure due to age and require rehabilitation and repair; and

WHEREAS, in accordance with the Rules of this County Board, bids were called for by publication for the Sanitary Sewer Rehabilitation 2013 Project; and

WHEREAS, subsequent to said publication, invitations to bid were extended to twenty-eight (28) contractors; and

WHEREAS, six (6) sealed bids were received and publicly opened in the office of the Public Works Department on Wednesday, July 17, 2013, at 2:00 p.m., and

WHEREAS, National Power Rodding Corp. is the lowest responsive and responsible bidder in the amount of \$1,660,023.56; five (5) other bids were received, ranging from \$1,699,650.25 to \$2,332,310.00.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized and directed to execute a contract with national Power Rodding Corp., Chicago, IL in the amount of \$1,660,023.56 for the Sanitary Sewer Rehabilitation 2013 Project and charging the costs thereof to Account Numbers 610-4867498-48310 and 610-4823398-48310.
