Joint resolution authorizing a contract with Maneval Construction Inc., Ingleside, Illinois, in the amount of \$533,116 for the Sanitary Sewer Improvements Project.

- As part of the County/Kildeer agreement in which the County assumed ownership of the Kildeer sewer system, Kildeer provided funds to the County to reroute its sewer flow from the Lake Zurich sewer system into the County sewer system.
- An invitation to bid was extended to 15 vendors and responses were received from five contractors, ranging from \$533,116 to \$748,444.
- Maneval Construction Inc. submitted the lowest responsive and responsible bid in the amount of \$533,116.
- This resolution authorizes the execution of a contract with Maneval Construction Inc., Ingleside, Illinois in the amount of \$533,116.

RESOLUTION

WHEREAS, the County of Lake (County) owns and operates sanitary sewer systems, including the Des Plaines River Water Reclamation Facility, that serves the Village of Kildeer (Village) within the Southeast Lake Facilities Planning Area; and

WHEREAS, the County and the Village have entered into Agreement in which the County has assumed ownership and operation of the Village’s collection system; and

WHEREAS, as a condition of the Agreement, the County has agreed to bid and construct sewers to reroute a portion of the Village of Kildeer flows from Lake Zurich’s collection system directly to the

County collection system; and

WHEREAS, in accordance with the Lake County Purchasing Ordinance, bids were called for by publication for the Sanitary Sewer Improvements Project; and

WHEREAS, subsequent to said publication, invitations to bid were extended to fifteen (15) contractors; and

WHEREAS, five (5) sealed bids were received and publicly opened in the office of the Lake County Public Works Department on Tuesday, April 13, 2015, at 2:00 p.m.; and

WHEREAS, Maneval Construction Inc., Ingleside, Illinois, is the lowest responsible bidder in the amount of \$533,116; four other bids were received, ranging from \$553,579 to \$748,444.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized and directed to execute a contract with Maneval Construction Inc., Ingleside IL, in the amount of \$533,116 for the Sanitary Sewer Improvements Project charging the costs thereof to various account numbers.
