Joint resolution appropriating \$618,000 of Motor Fuel Tax funds for the maintenance of the County highway system from December 1, 2012, to November 30, 2013, and designated as Section 13-00000-00-GM.

- 2013 Motor Fuel Tax Fund, Patrol 1 Maintenance Materials: Appropriation.
- Patrol 1 are those maintenance materials and activities paid out of the Motor Fuel Tax fund, and include material supply contracts such as sign material and shoulder aggregate.
- An appropriation of \$618,000 of Motor Fuel Tax funds must be made prior to a letting being held.

### RESOLUTION

**WHEREAS**, in order to maintain the condition of the pavements, shoulders, and rights-of-way of the designated routes on the County highway system, the Division of Transportation annually undertakes various maintenance activities that utilize miscellaneous highway materials; and

**WHEREAS**, the estimated cost of highway materials to support the planned maintenance activities for 2013 is \$618,000.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that there is hereby appropriated \$618,000 of Motor Fuel Tax funds for the miscellaneous highway materials needed for fiscal year 2013 to support various maintenance activities on various county highways, and designated as Section 13-00000-00-GM.

**BE IT FURTHER RESOLVED** that this appropriation be processed by the Acting County Engineer for

final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 22, 2003.
